2. Data for some countries for the number of tests conducted are often not continuously updated and should be used with caution.
3. For The Bahamas, the number of deaths in the table includes 15 deaths that are under investigation and excludes 22 deaths that are classified as due to non-COVID-19 causes. The total number of deaths of COVID-19 patients is 146.
4. For Jamaica, the number of deaths in the table includes 19 deaths that are under investigation and excludes 10 deaths that are classified as due to non-COVID-19 causes. The total number of deaths of COVID-19 patients is 180.
5. There is a lag (2 days) in the reporting of data on Haiti.
6. The Testing data for Trinidad and Tobago excludes tests that are done privately. An estimate for this figure is over 15,000.
