Preface

The first edition of this report, in October 2001, started out simply as an attempt to make available for both internal and external users, key economic indicators of CARICOM Member States in a single publication. As the report developed and the problems of compiling a consistent and reliable data set across all Member States were exposed, the publication grew into an attempt to bring to the fore the issues of harmonisation of statistics in the Region.

Harmonisation of statistics demands, or necessitates, that we have common data with harmonised or equivalent definitions that can be reliably compared across all Member States. With the creation of the CARICOM Single Market and Economy (CSME), the achievement of harmonisation of statistics is a crucial concern at the Regional and National levels. The monitoring of the performance of the CSME is only possible if there is a core set of statistics that are comparable and timely.

In the last edition of the report, a supplementary bulletin was produced which provided some brief highlights of the major trends in the data. These data highlights have now been incorporated in this report and examines the data for the years 2013 and 2014. In addition, a study of some of the trends may lead to the question of data reliability and accuracy, which may stimulate the need to re-examine the data at the source.

It is obvious that a lot more work is required, but this publication makes an initial effort to embark on the task of going deeper into the methodologies in use in the Region, and producing a core set of socio-economic, environment and information and communication technology (ICT) indicators and eventually a comprehensive set of sustainable development statistics indicators.

*The Statistics Programme welcomes any suggestions as to how the issues highlighted in the **Notes about the Data** can lead to an improvement of the quality, comparability and availability in general of these statistics in the Region.*

Data Highlights

Real GDP

2014

- *The Region's real GDP increased by 0.3 percentage points moving from 1.2 percent in 2013 to **1.5 percent** in 2014.*
- *St. Kitts and Nevis' growth rate was strong at **6.9 percent**, the highest in the Region. This was followed by Belize at **3.9 percent**, Grenada at **3.8 percent** and Guyana, also **3.8 percent** but falling by 2.5 percentage points from the previous year.*
- *In the case of the larger economies, Trinidad and Tobago's economy expanded by **1.9 percent** over 2013 while Jamaica experienced marginal growth, **0.5 percent**.*
- *Saint Lucia was the only Member State whose economy contracted in 2014 at **-1.6 percent**.*

2013

- *There was weak growth of real GDP for the Region as a whole at **1.2 percent** over the previous year.*
- *Guyana and St. Kitts and Nevis reported the highest growth rates, **6.3 percent** and **5.8 percent** respectively.*
- *The larger economies, Trinidad and Tobago and Jamaica, saw their real GDP grow by **1.7 percent** and **0.2 percent** respectively.*
- *The economies of Antigua and Barbuda (**-0.1 percent**) and Saint Lucia (**-0.4 percent**) contracted during the period while Barbados did not record any significant movement.*

Consumer Price Index

2014

- *Jamaica reported an annual average inflation rate of **8.3 percent** in 2014, one percentage point less than the previous year but still the highest in the Region.*
- *Trinidad and Tobago followed with **5.7 percent**.*
- *Grenada and Montserrat experienced deflation at **-1.0 percent** and **-0.3 percent** respectively.*

2013

- *The inflation rate in Jamaica grew by 2.4 percentage points from 2012's rate to **9.3 percent** in 2013, while in Trinidad and Tobago it fell by 4 percentage points to **5.2 percent**.*
- *Dominica, Grenada and Montserrat all experienced negative inflation at **-0.7 percent**, **-0.3 percent** and **-0.4 percent** respectively.*

Unemployment Rate ¹

2014

- *Based on available data, Saint Lucia had the highest unemployment rate in the Region in 2014 at **24.4 percent**.*
- *In The Bahamas the unemployment rate was **14.8 percent** while in Jamaica it was **13.7 percent**.*
- *Unemployment in Trinidad and Tobago was the lowest in the Region at **3.3 percent** of the total labour force.*

2013

- *At **33.4 percent**, Grenada had the highest unemployment rate in the Region in 2013 according to the available data. Saint Lucia followed with an unemployment rate of **23.3 percent**.*
- *The Bahamas and Jamaica both had unemployment rates above 15 percent, reporting **15.8 percent** and **15.3 percent** respectively.*
- *Trinidad and Tobago's unemployment rate, the lowest in the Region, fell to **3.7 percent** from 5.0 percent in 2012.*

Structure of GDP

Industry as percentage of Country's GDP

2014

- *The services sector was the most significant industry in all countries of the Region accounting for over **47 percent** of each country's total GDP and **62.8 percent** of the Region's total GDP.*
- *In The Bahamas, the services sector accounted for **91.9 percent** of GDP while in Barbados it was **76.9 percent** and **70.1 percent** in Jamaica.*
- *In the OECS sub-region as a whole, services accounted for **74.9 percent** of the sub-region's GDP. There were marginal decreases in the share of services to GDP in six of the seven OECS countries when compared to 2013; only in Dominica was there a slight increase.*
- *Mining and quarrying (**31.0 percent**) and manufacturing (**19.4 percent**) were the next major industries after services (**47.2 percent**) in Trinidad and Tobago.*
- *In Guyana, agriculture (**16.2 percent**) and mining and quarrying (**13.3 percent**) were the next most significant industries after services (**53.5 percent**), while in Suriname manufacturing (**16.3 percent**) and agriculture (**9.1 percent**) followed services (**60.1 percent**).*

2013

- *The services sector was the largest contributor to economies of the Region accounting for **62.5 percent** of the Region's total GDP and for over **46 percent** of countries' total GDP.*

¹ In 2013, data were available for seven countries only: The Bahamas, Barbados, Belize, Grenada, Jamaica, Saint Lucia and Trinidad and Tobago. In 2014, data were available for five countries: Barbados, Belize, Jamaica, Saint Lucia and Trinidad and Tobago.

- *Services was The Bahamas' single most important sector at **91.5 percent** of total GDP.*
- *In Barbados, Jamaica and the OECS grouping, the sector's contribution to GDP was **77.2 percent**, **70.5 percent** and **75.3 percent** respectively. Services share of GDP in the OECS member countries ranged from **63.3 percent** (Dominica) to **84.0 percent** (Montserrat).*
- *In the case of Trinidad and Tobago, the share of services to total GDP was estimated at **46.8 percent**. Mining and quarrying was **30.5 percent** while manufacturing was **20.3 percent**.*
- *The services sector's contribution to the Guyanese economy was **51.0 percent**, followed by agriculture (**16.5 percent**) and mining and quarrying (**15.8 percent**).*
- *In Suriname, the contribution of services to GDP stood at **57.0 percent**; manufacturing (**18.8 percent**) was the next major industry followed by agriculture (**8.1 percent**).*

Industry as a percentage of CARICOM's GDP in the specified industry

2014

Agriculture:

- *The major contributor to agriculture GDP in the Region in 2014 was Jamaica accounting for **31.9 percent** of the Region's agriculture GDP.*
- *Guyana (**19.3 percent**) and Suriname (**18.4 percent**) were the other two main contributors.*

Mining and Quarrying:

- *Trinidad and Tobago dominated this industry region-wide accounting for **89.9 percent** of the Region's total mining and quarrying GDP.*
- *Guyana and Suriname followed contributing **4.2 percent** and **2.4 percent** respectively.*

Manufacturing:

- *Trinidad and Tobago was the clear leader in the manufacturing sector in the Region, accounting for **64.7 percent** of the Region's manufacturing GDP.*
- *Jamaica (**13.2 percent**) and Suriname (**10.1 percent**) were the next highest contributors.*

Services:

- *Trinidad and Tobago was the highest contributor to services GDP in the Region; this country's share of the total regional services GDP stood at **30.0 percent**.*
- *Jamaica followed with **22.0 percent** and The Bahamas with **17.6 percent**.*

2013

Agriculture:

- *With a share of **33.6 percent**, Jamaica was the top contributor to the Region's agriculture GDP.*
- *The other major contributors were Guyana (**19.7 percent**) and Suriname (**16.4 percent**).*

Mining and Quarrying:

- *Trinidad and Tobago was the most dominant player in this industry in the Region with its share of the Region's total mining and quarrying GDP growing by 1.7 percentage points from 2012's position to **88.7 percent** in 2013.*
- *At distant second and third positions were Guyana (**5.0 percent**) and Suriname (**3.1 percent**).*

Manufacturing:

- *In 2013, Trinidad and Tobago's share of CARICOM's manufacturing GDP stood at **63.7 percent**.*
- *Jamaica followed with **13.2 percent** while Suriname accounted for **11.1 percent** of the Regions' manufacturing GDP*

Services:

- *At the regional level, the largest contributor to the services sector in 2013 was Trinidad and Tobago, accounting for **29.5 percent** of the Region's services GDP.*
- *Jamaica had the second highest share at **23.0 percent** followed by The Bahamas with **17.7 percent**.*

Gross National Saving²

2014

- *Based on available data, the ratio of gross national saving to GDP was highest in the Region in Belize at **25.4 percent**.*
- *St. Kitts and Nevis had the second highest percentage at **23.7 percent** of GDP.*
- *In Montserrat, private and public final consumption expenditure exceeded disposable income resulting in a negative saving which was **-25.4 percent** of GDP.*

2013

- *Gross national saving was **25.0 percent** of St. Kitts and Nevis' GDP, the highest in the Region based on available data, followed by Belize (**24.2 percent**).*
- *Montserrat's saving to GDP ratio was **-22.0 percent**.*

Overall Fiscal Deficit/Surplus

2014

- *St. Kitts and Nevis was the only Member State to record a fiscal surplus in 2014, measuring **10.5 percent** of its GDP.*

² Data for Barbados, Guyana, Suriname and Trinidad and Tobago were not available.

- *Jamaica's government operations slipped into deficit in 2014 and stood at **-0.5 percent** of GDP.*
- *The highest fiscal deficit to GDP ratios in the Region were recorded in Barbados (**-7.2 percent**) and Montserrat (**-5.8 percent**).*

2013

- *In Jamaica, the overall fiscal surplus was a mere **0.1 percent** of GDP, while in St. Kitts and Nevis it was **13.2 percent**. These were the only two Member States to report a fiscal surplus in 2013.*
- *Montserrat and Barbados had the highest deficits when measured as a percentage of GDP, standing at **-16.8 percent** and **-12.5 percent** respectively.*

Merchandise Trade Balance

2014

- *In 2014, Trinidad and Tobago's merchandise trade surplus fell to almost half of its 2013 level, at **11.7 percent** of its GDP.*
- *Suriname's surplus also fell from its 2013 level, to **2.6 percent** of GDP.*
- *Except for these two Member States, the other countries all reported merchandise trade deficits in 2014.*

2013

- *All the Member States, except Trinidad and Tobago and Suriname, experienced merchandise trade deficits in 2013.*
- *The merchandise trade balance of Trinidad and Tobago was **22.3 percent** of its GDP while Suriname's was **4.7 percent**.*
- *The country with the largest trade deficit to GDP ratio was Montserrat at **-52.0 percent**.*

International Trade in Services Balance

2014

- *Measured as a percentage of GDP, the trade in services surplus was the highest in Barbados and Antigua and Barbuda at **23.0 percent** and **21.5 percent** of their respective GDP.*
- *Four Member States - Guyana, Montserrat, Suriname and Trinidad and Tobago - recorded deficits in their trade in services balances during 2014.*
- *Montserrat and Suriname had the largest services trade deficits reported at **-23.4 percent** and **-10.6 percent** of their respective GDP.*

2013

- *Barbados and Antigua and Barbuda reported the highest surplus in trade in services in the Region relative to their GDP at **23.4 percent** and **22.0 percent** respectively.*

- *Guyana, Montserrat, Suriname and Trinidad and Tobago all experienced negative services trade balances.*
- *Montserrat, at **-26.2 percent**, had the highest deficit as a percentage of GDP, followed by Guyana (**-11.2 percent**) and Suriname (**-7.3 percent**).*

Current Account Balance

2014

- *Although the surplus fell compared to 2013, Trinidad and Tobago was the **only** Member State to report a positive current account balance, which stood at **1.3 percent** of GDP in 2014.*
- *Montserrat and St. Vincent and the Grenadines had the largest current account deficits relative to their GDP.*
- *In Montserrat the current account balance to GDP was **-43.8 percent**, while in St. Vincent and the Grenadines it was **-29.6 percent**.*

2013

- *Trinidad and Tobago was the only CARICOM Member State to report a positive current account balance in 2013; this balance was **12.5 percent** of the country's GDP.*
- *Montserrat and St. Vincent and the Grenadines experienced the largest current account deficits relative to their GDP.*
- *The current account balance to GDP ratio in Montserrat was **-48.2 percent**, while in St. Vincent and the Grenadines it was **-30.9 percent**.*

External Debt Outstanding³

2014

- *Though marginally less than in 2013, at **66.3 percent**, Belize had the highest outstanding external public debt to GDP ratio in the Region in 2014 based on the available data.*
- *This Member State was closely followed by Grenada (**65.5 percent**) and Jamaica (**64.6 percent**).*
- *Montserrat (**4.2 percent**) reported the lowest external public debt to GDP ratio.*

2013

- *Based on available data, Grenada had the highest outstanding external public debt to GDP ratio in the Region in 2013 at **69.1 percent**.*
- *In Belize this ratio was **66.7 percent** while in Jamaica it was **61.8 percent**, the second and third highest in the Region.*
- *According to the available data, this ratio was the lowest in Montserrat (**4.2 percent**).*

³ Data for Barbados, Dominica, Guyana and St. Kitts and Nevis were not available.

Debt Service Ratio⁴

2014

- *Based on available data, the debt service ratio in the region was highest in Jamaica at **20.4 percent**.*
- *In St. Vincent and the Grenadines, this ratio was **16.1 percent**, while in Belize it was **7.1 percent**.*
- *Trinidad and Tobago and Suriname had the lowest debt service ratios in the Region in 2014, at **1.0 percent** and **2.2 percent** respectively, according to available data.*

2013

- *In 2013, the debt service ratio in St. Vincent and the Grenadines stood at **18.1 percent** while in Jamaica it was **14.9 percent** and **11.0 percent** in Belize.*
- *Based on the available data, these were the only countries where the debt service ratio was over 10 percent.*
- *In Trinidad and Tobago, the debt service ratio was **0.9 percent** and in Suriname, **1.3 percent**.*

Domestic Credit to the Private Sector

2014

- *At the regional level, domestic credit to the private sector was **35.5 percent** of the Region's total liabilities, unchanged from 2013.*
- *In The Bahamas, domestic credit to the private sector was **57.5 percent** of that country's total liabilities while in Belize it was **46.3 percent** of total liabilities and **37.8 percent** in Barbados.*
- *Domestic credit to the private sector was **38.5 percent** of total liabilities in the OECS sub-grouping.*

2013

- *In 2013, domestic credit to the private sector was **35.5 percent** of total liabilities for the Region.*
- *In The Bahamas, the ratio of domestic credit to the private sector to total liabilities was **58.8 percent**. In Belize, this ratio was **48.0 percent** while in Barbados it was **39.2 percent**.*
- *In the OECS sub-grouping, domestic credit to the private sector was **40.9 percent** of total liabilities.*

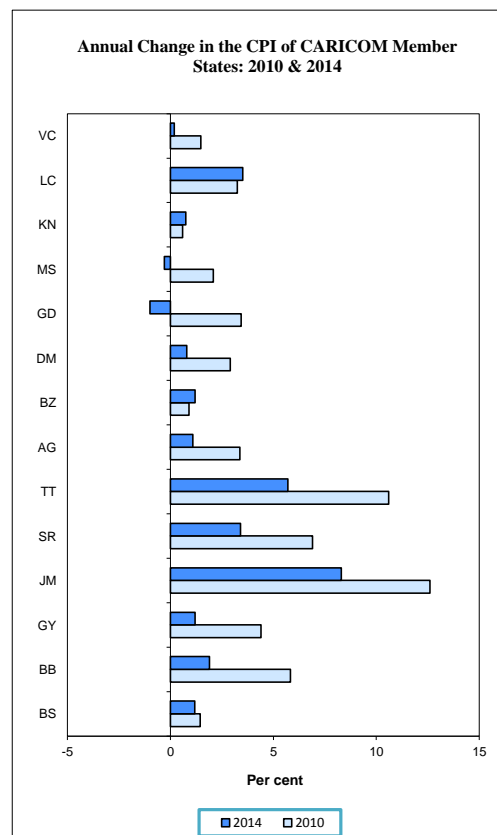
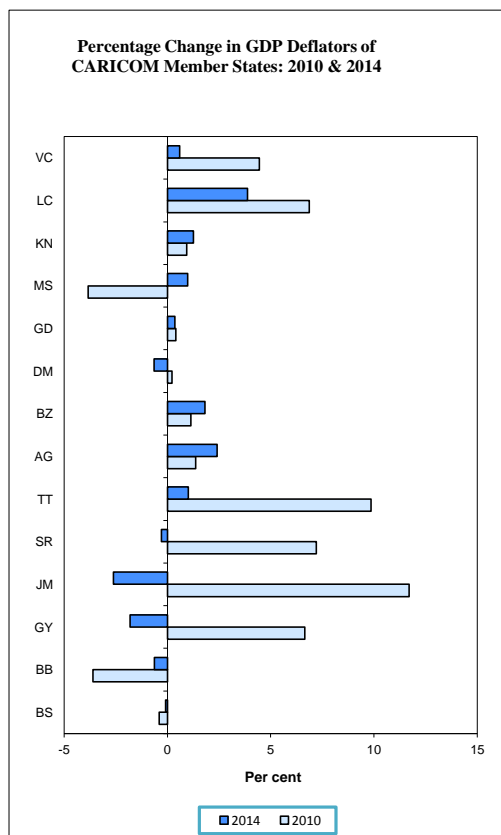
GNI of Selected CARICOM Member States and the OECS Group: 2010-2014



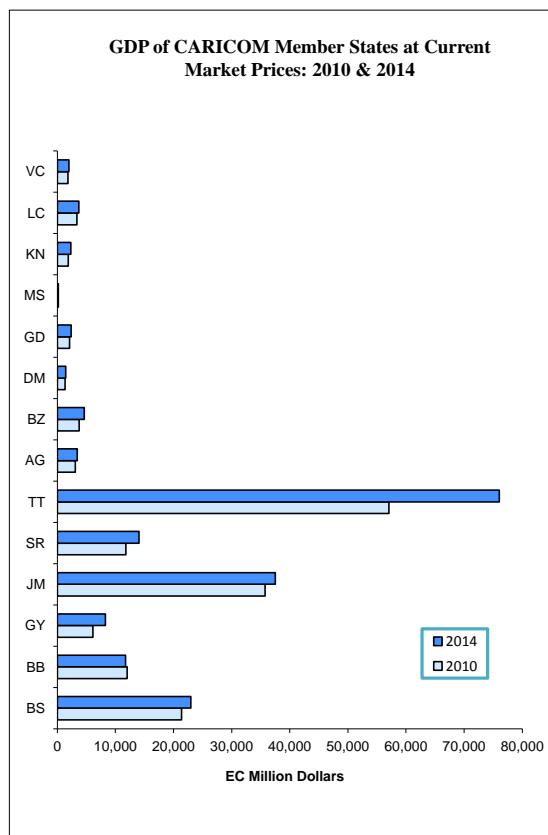
GNI Per Capita of CARICOM Member States: 2010 & 2014



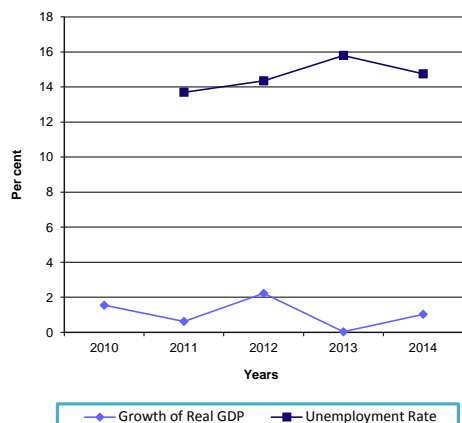

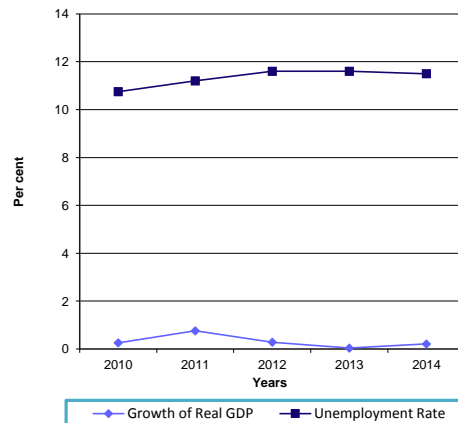

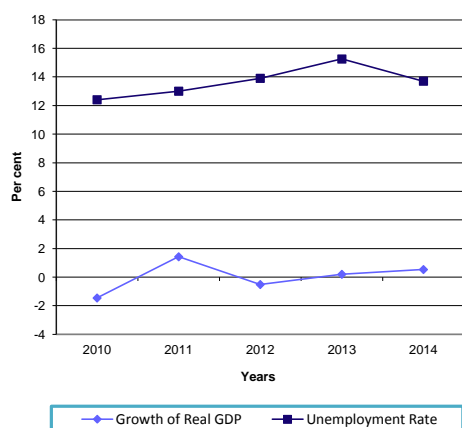
The Bahamas' Growth of Real GDP and Unemployment Rate: 2010-2014



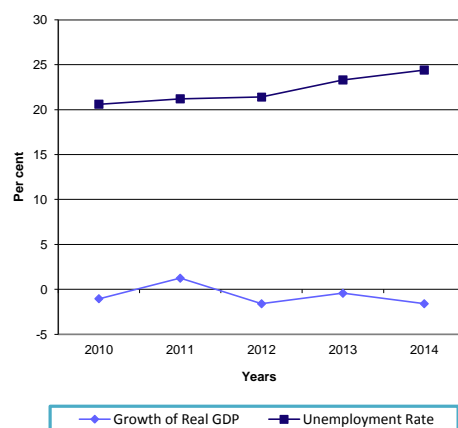
Barbados' Growth of Real GDP and Unemployment Rate: 2010-2014



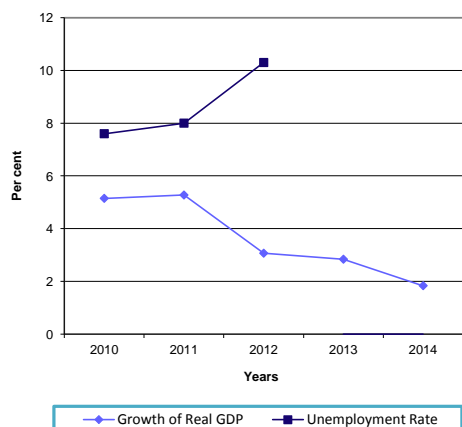
Jamaica's Growth of Real GDP and Unemployment Rate: 2010-2014



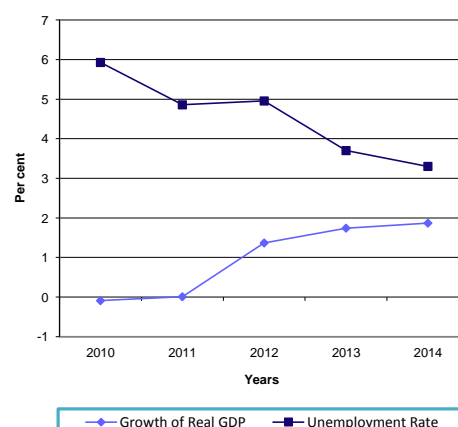
Saint Lucia's Growth of Real GDP and Unemployment Rate: 2010-2014



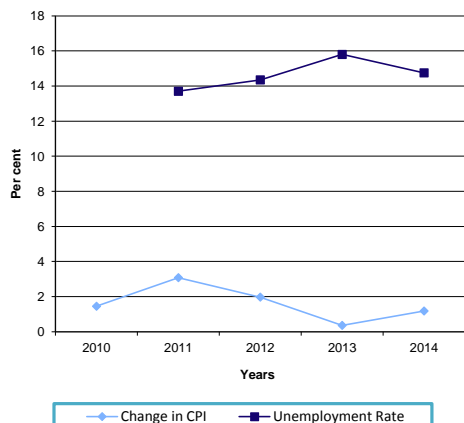
Suriname's Growth of Real GDP and Unemployment Rate: 2010-2014



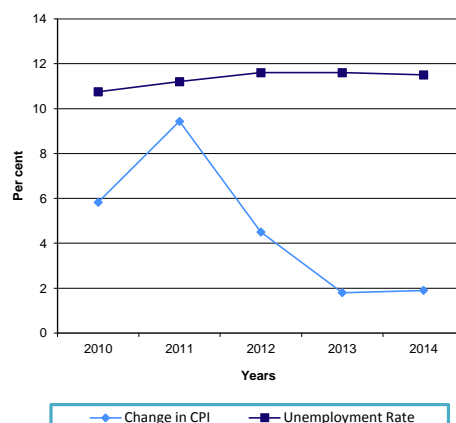
Trinidad and Tobago's Growth of Real GDP and Unemployment Rate: 2010-2014



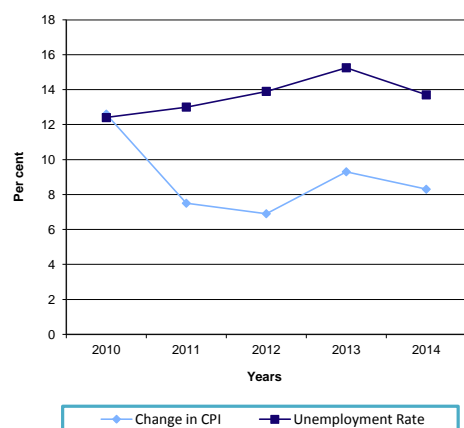
The Bahamas' Unemployment Rate and Annual Change in the CPI: 2010-2014



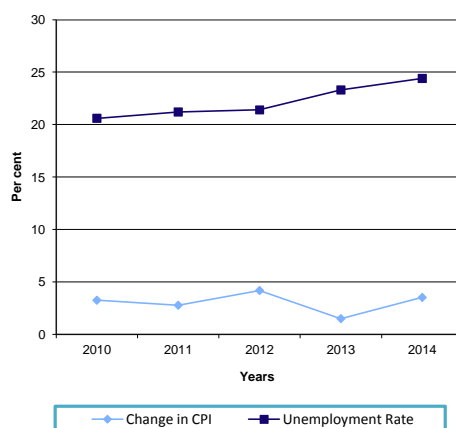
Barbados' Unemployment Rate and Annual Change in the CPI: 2010-2014



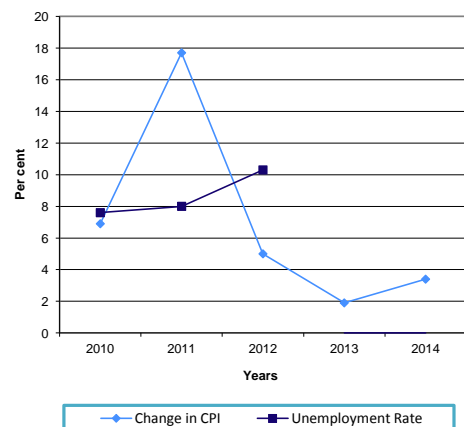
Jamaica's Unemployment Rate and Annual Change in the CPI: 2010-2014



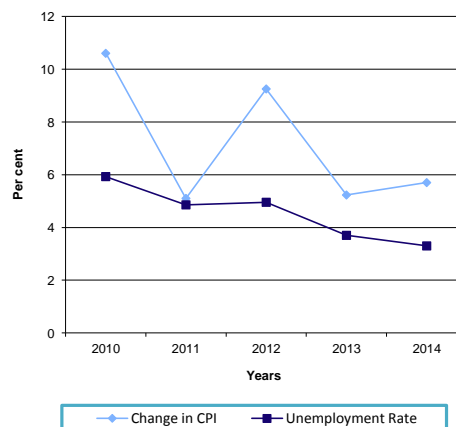
Saint Lucia's Unemployment Rate and Annual Change in the CPI: 2010-2014



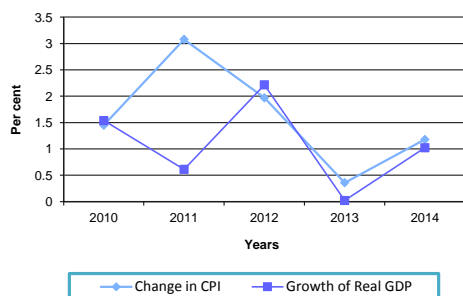
Suriname's Unemployment Rate and Annual Change in the CPI: 2010-2014



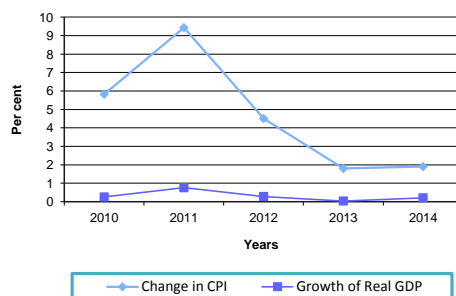

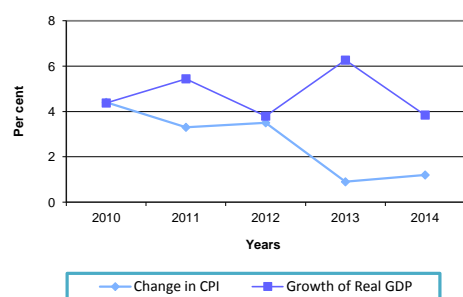
The Bahamas' Annual Change in the CPI and Growth of Real GDP: 2010-2014



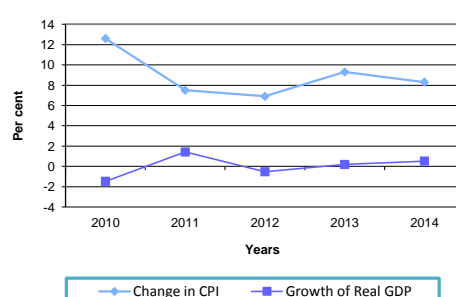
Barbados' Annual Change in the CPI and Growth of Real GDP: 2010-2014



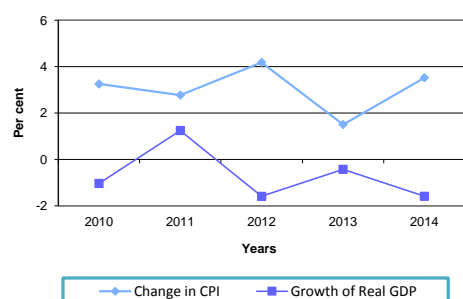
Guyana's Annual Change in the CPI and Growth of Real GDP: 2010-2014



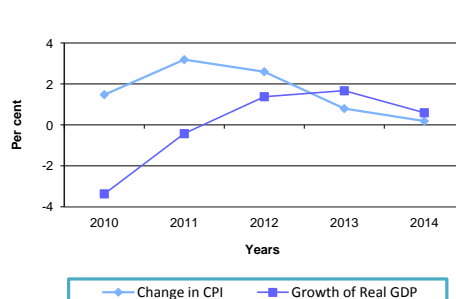
Jamaica's Annual Change in the CPI and Growth of Real GDP: 2010-2014



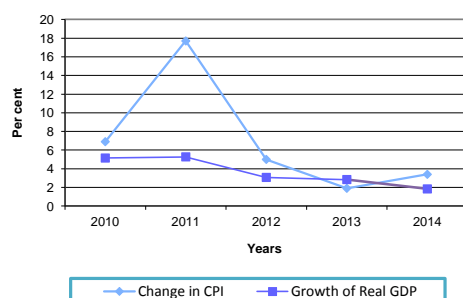
Saint Lucia's Annual Change in the CPI and Growth of Real GDP: 2010-2014



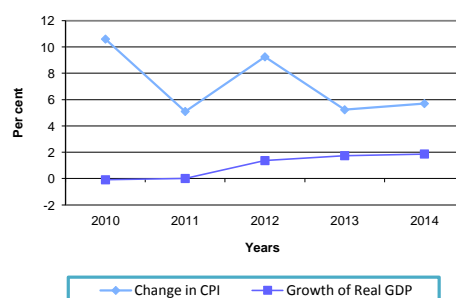
St. Vincent & the G'Dines' Annual Change in the CPI and Growth of Real GDP: 2010-2014



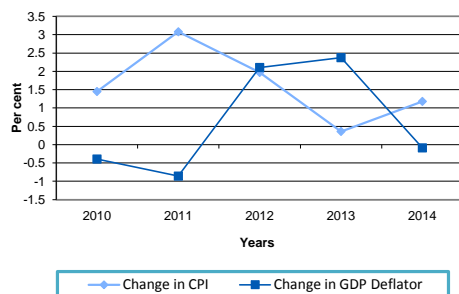
Suriname's Annual Change in the CPI and Growth of Real GDP: 2010-2014



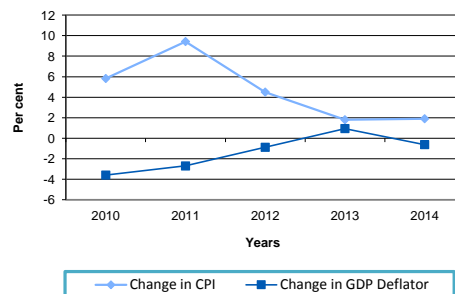
Trinidad & Tobago's Annual Change in the CPI and Growth of Real GDP: 2010-2014



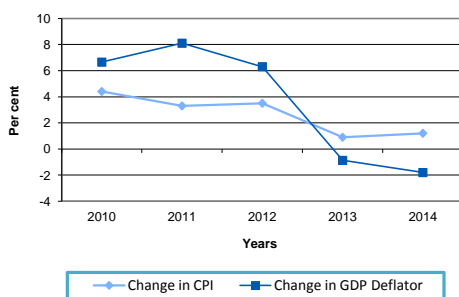
The Bahamas' Annual Changes in the CPI and GDP Deflator: 2010-2014



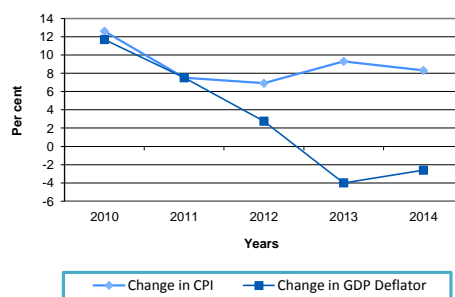
Barbados' Annual Changes in the CPI and GDP Deflator: 2010-2014



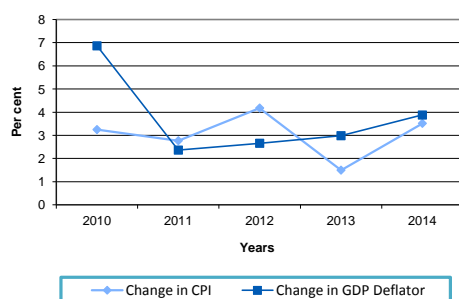
Guyana's Annual Changes in the CPI and GDP Deflator: 2010-2014



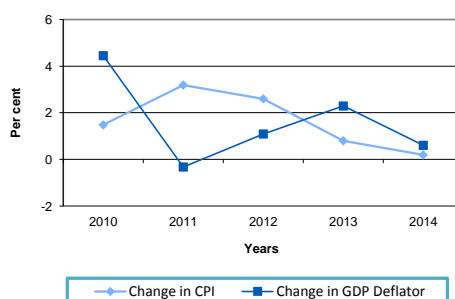
Jamaica's Annual Changes in the CPI and GDP Deflator: 2010-2014



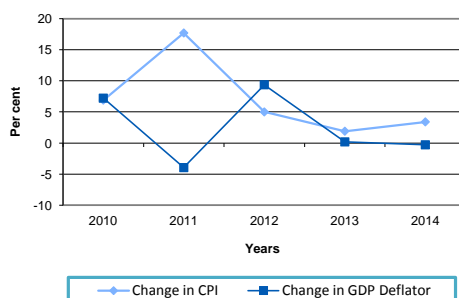
Saint Lucia's Annual Changes in the CPI and GDP Deflator: 2010-2014



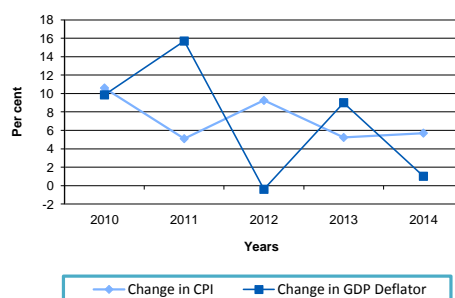
St. Vincent & the G'Dines' Annual Changes in the CPI and GDP Deflator: 2010-2014

Notes about the Data

Gross Domestic Product

Estimates of Gross Domestic Product (GDP) at constant prices have been prepared at various base years across the Member States of the Caribbean Community (CARICOM). For Barbados, it was prepared at constant 1974 prices; Belize and Trinidad and Tobago's are at base year 2000; those for the Bahamas, Guyana and the member countries the Organisation of Eastern Caribbean States (OECS) are at 2006 prices, while Jamaica and Suriname both use the year 2007. In the case of Guyana and Suriname, only the data from 2006 onwards were reported at the new base years; data prior to 2006 were reported at the earlier base years, i.e. 1988 and 1990 respectively.

In an effort to arrive at regionally comparable data, the constant price data for those countries with a base year other than 2006 have been arithmetically recalculated from the original base year to the year 2006. This approach of deriving a common base year is a 'second best' method. Ideally, the best approach would be to use the detailed price and quantity measures at the individual country level to re-base the GDP at constant prices.

Although the base years have been standardised in this report, the data at constant 2006 prices are still not totally comparable. Data for Dominica, Guyana and Jamaica are valued at basic prices; Barbados' estimates are at factor cost while estimates for all the other countries are at constant market prices. At current prices, the countries all reported the data in market prices.

Conversion of the data from national currencies to Eastern Caribbean (EC) dollars for some of the non-OECS Member States generates the problem

of annual changes at constant prices being larger than the corresponding changes at current prices for specific Member States. In addition, relative changes in current prices between Member States are affected by the uncoordinated movements between changes in exchange rates and prices. There were also differences in changes in current prices in EC dollars as compared to similar changes in national currency of the affected country.

Growth of Real GDP

Growth rates were calculated as the annual change in the real GDP in constant 2006 prices. Since shifting the base years for those countries with base years other than 2006 was done arithmetically, growth rates for these countries would not differ from the growth rates derived using the national base years. However, as noted above, in the case of Guyana and Suriname both of which adopted new base years but without extending the new series backwards, the growth rate for 2005 for these two countries would not be strictly comparable with the rest of the series. This issue would also extend to the growth of real GDP per capita for 2005 for the two countries.

Gross National Income

Gross National Income (GNI) data are presented in market prices for all Member States.

GDP Deflators

Caution should be exercised when attempting to interpret the changes in the GDP deflators. Again, because some countries reported their constant GDP estimates in basic prices while others prepared theirs in market prices, the changes at the group levels and individual country levels for some

countries are therefore not entirely comparable.

Consumer Price Index

The data presented on Consumer Prices represent the inflation rates of Member States as measured by the percentage changes in the annual average Consumer Price Index (CPI) of the respective Member State. In the case of Guyana, the data refer to the percentage change in the end of period CPI.

It should be noted that differences in the Consumer Price Indices exist across Member States relative to the base year of the indices, the composition of the basket of goods and the geographic area covered within countries. In some instances, the prices data reflect only one part of the country, for example, urban areas, or just one city. For example, the CPI data for Suriname refer to Paramaribo and Wanica districts only while in the case of Guyana, the data refer to the capital city, Georgetown. However, due to the relatively small sizes/population of the CARICOM Member States, the annual changes are taken as being representative of the entire country. It may be the case, however, that in rural areas, prices are higher and these are not reflected in the index.

In some Member States, an Index of Retail Prices or Retail Price Index (RPI) is compiled rather than a CPI and the annual changes in this index were used to determine the inflation rate for those countries.

Unemployment Rates

Labour Force data are compiled from surveys conducted by the Member States. However, not all countries conduct regular surveys. For some countries, the only data on employment that are available are

derived from the decennial population censuses.

There are differences in the reference periods among Member States for the measurement of economic activity. The size of the Labour Force will also depend on the time of the year when the survey was conducted, which implies that seasonality could affect the data. Some countries conduct quarterly surveys and in these cases the average of the four quarters was used for the annual figure. In some cases, countries do not estimate an average for the entire year and the unemployment rate is for a specific point in time during the year.

In addition, some Member States use the population '15 years and over' to measure economic activity while others use the '14 years and over' age group.

Concepts and Definitions

Real Gross Domestic Product

The Gross Domestic Product (GDP) is the total market value of goods and services produced in the country within a given period of time, after deduction of the cost of goods and services used up in the process of production, but before deduction of allowances for the consumption of fixed capital. It is the sum of the gross value added by all resident and non-resident producers in the economy plus any taxes minus subsidies not included in the value of production.

Gross National Income Per Capita

Gross Domestic Product plus net income from abroad equals the gross national income (GNI). GNI per capita is the total gross national

income divided by the estimated total mid-year population.

GDP Implicit Price Deflator

The GDP implicit price deflator is the ratio of current prices over constant prices expressed as a percentage. This is one measure of general price changes in the economy, taking into account changes in the prices of all the final demand categories such as government consumption, capital formation, international trade and private final consumption expenditure.

Consumer Price Index

The Consumer Price Index (CPI) is a measure designed to monitor the changes in the prices prevailing in an economy based on a fixed basket of goods and services usually from one month to the next and sometimes based on a defined group of households or persons. It is a reflection of changes in prices as they affect the average consumer in the acquisition of goods and services.

Unemployment Rate

The unemployment rate measures the total unemployed as a percentage of the total labour force during a defined reference period.

Sources of Data

National Accounts data (GDP, GNI) were compiled from data produced by the National Statistics Offices (NSOs) of the Member States and for the most part were submitted through the United Nations National Accounts Questionnaires (NAQ).

Data on prices were originally extracted from web sites and publications/bulletins prepared by the NSOs and/or Central Banks of the respective Member States.

Labour Force data were submitted directly from the NSOs or were extracted from the NSOs' publications and web sites.

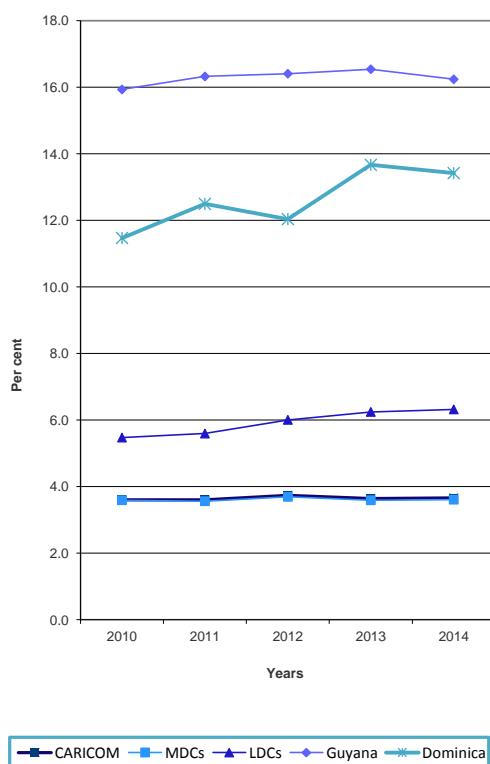

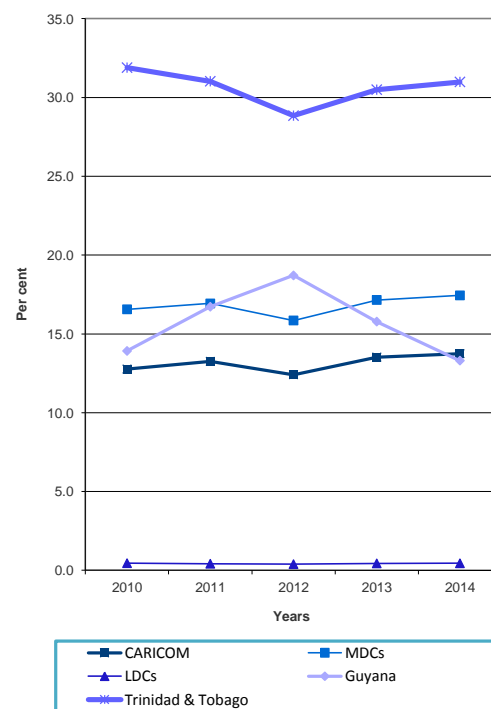

GDP: 2010-2014

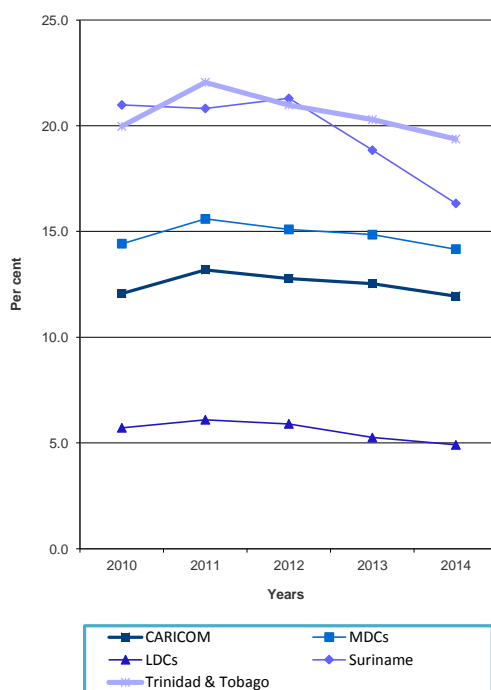


CARICOM, MDCs, LDCs, Guyana and Trinidad

to their Respective GDP: 2010-2014

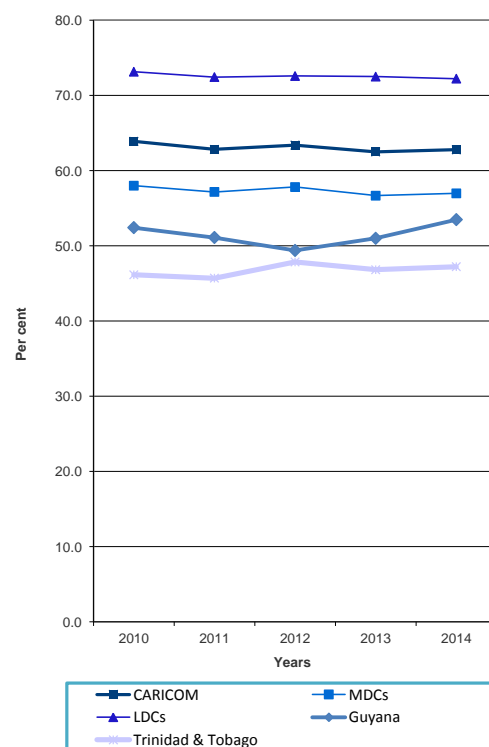

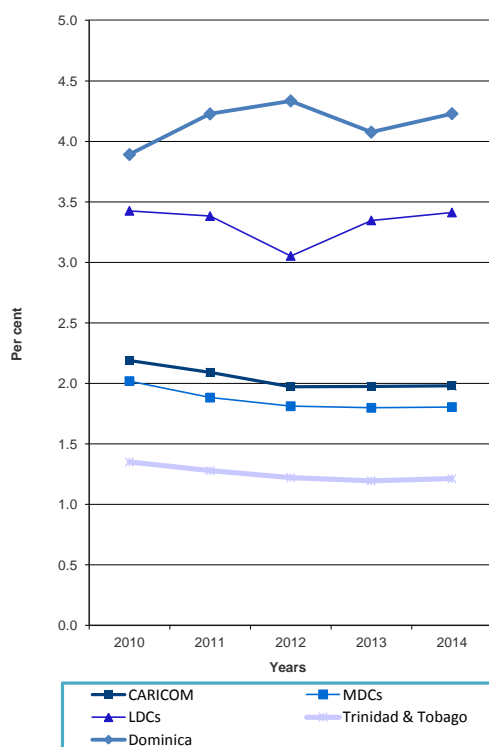


CARICOM, MDCs, LDCs, Guyana and Trinidad & Tobago's Contribution of Services to their Respective GDP: 2010-2014

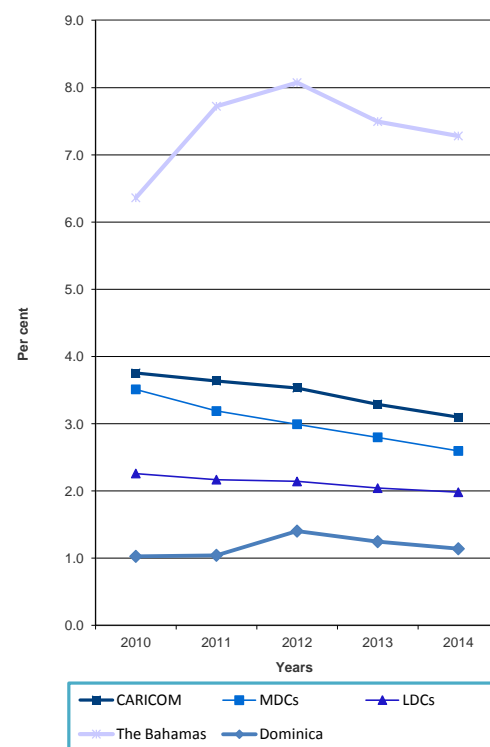

Respective GDP: 2010-2014

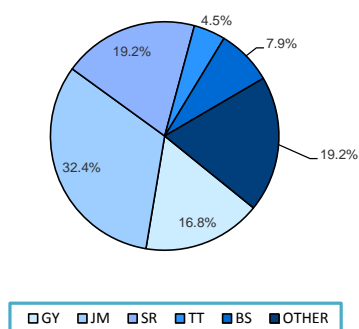

Respective GDP: 2010-2014

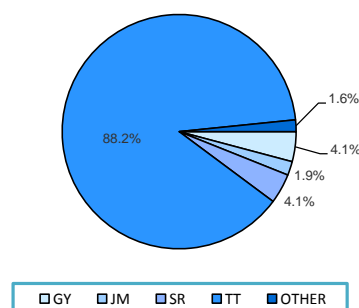

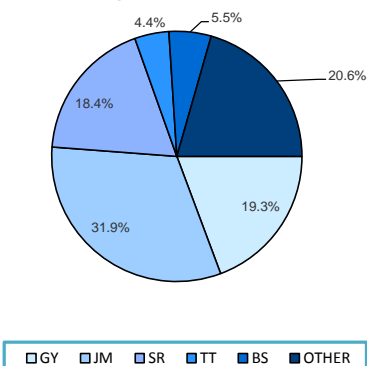
Member States Contribution to CARICOM's Total Agriculture GDP, 2010



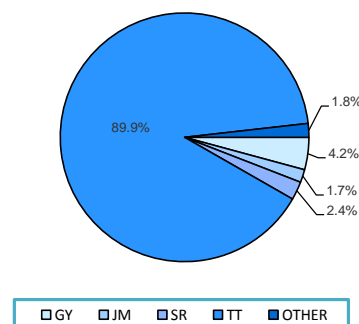
Member States Contribution to CARICOM's Total Mining & Quarrying GDP, 2010



Member States Contribution to CARICOM's Total Agriculture GDP, 2014

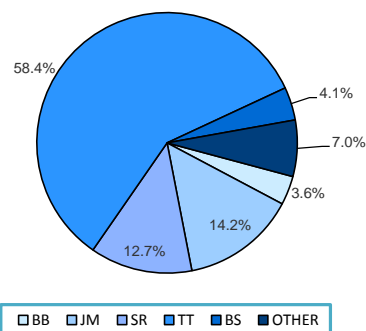


Member States Contribution to CARICOM's Total Mining & Quarrying GDP, 2014

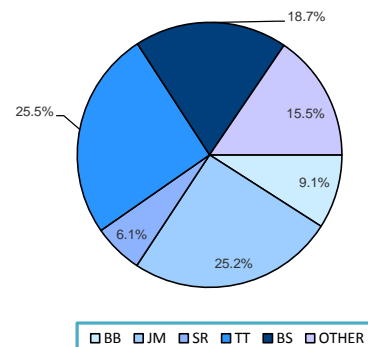

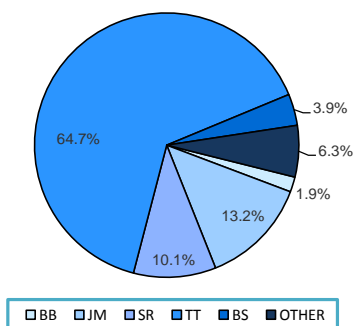
Member States Contribution to CARICOM's Total Manufacturing GDP, 2010



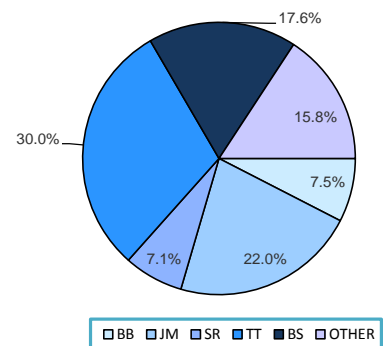
Member States Contribution to CARICOM's Total Services GDP, 2010



Member States Contribution to CARICOM's Total Manufacturing GDP, 2014

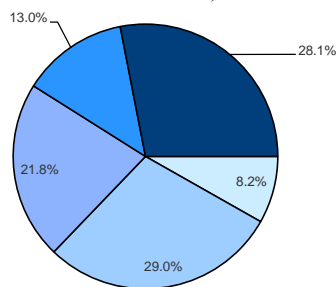


Member States Contribution to CARICOM's Total Services GDP, 2014

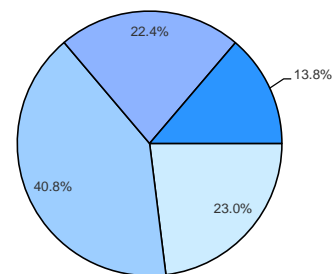

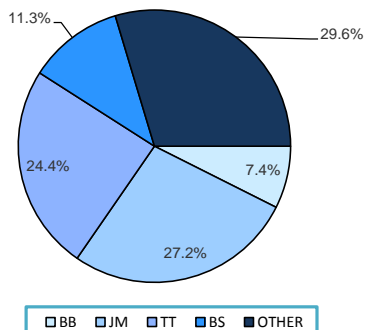
Member States Contribution to CARICOM's Total Utilities GDP, 2010



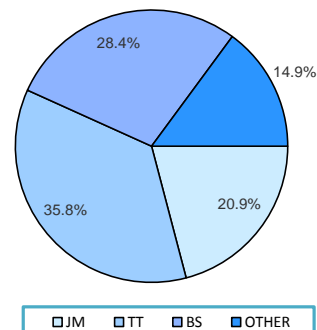
Member States Contribution to CARICOM's Total FISIM, 2010

Member States Contribution to CARICOM's Total FISIM, 2014



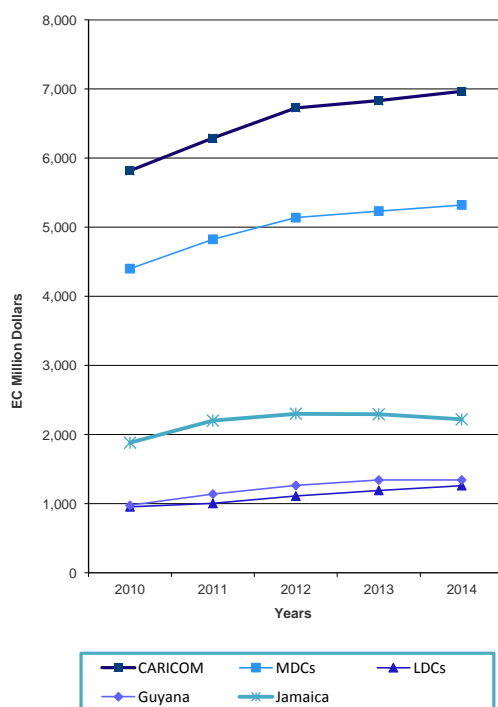

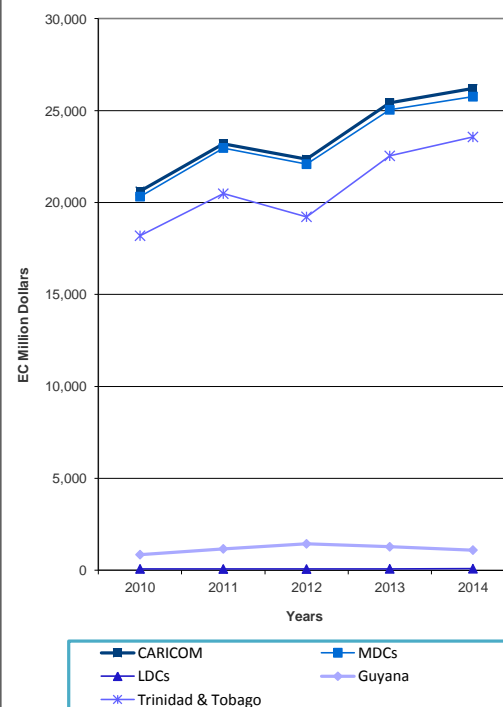

Value of CARICOM, MDCs, LDCs, Guyana and Jamaica's Agriculture Sector GDP: 2010-2014

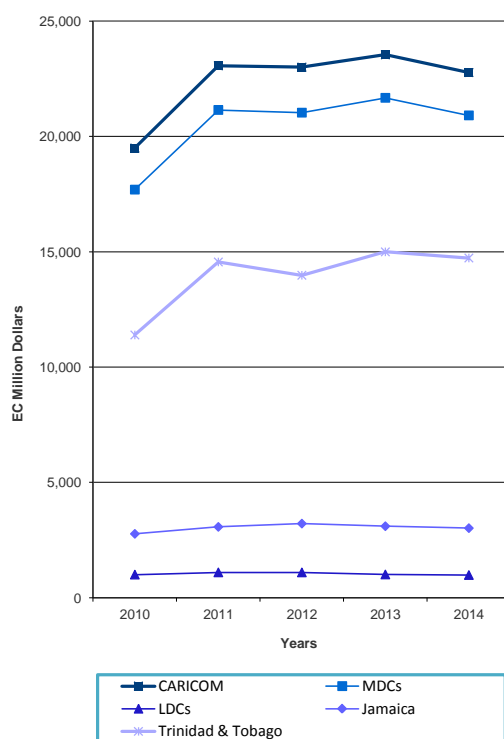


Value of CARICOM, MDCs, LDCs, Guyana and Trinidad & Tobago's Mining and Quarrying Sector GDP: 2010-2014

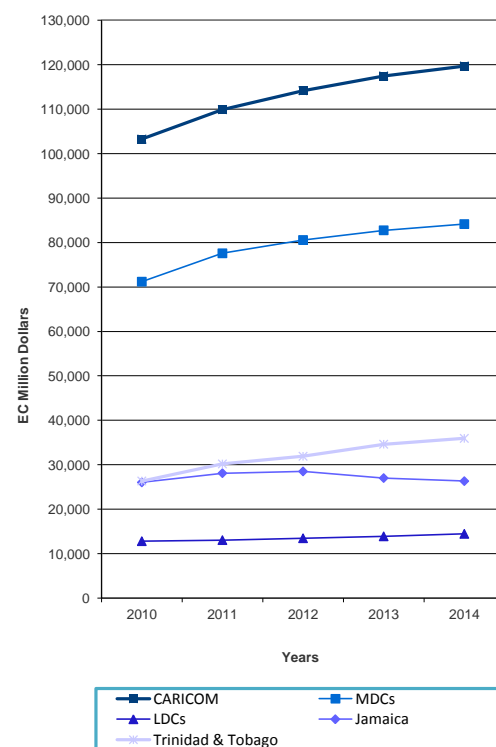

2014

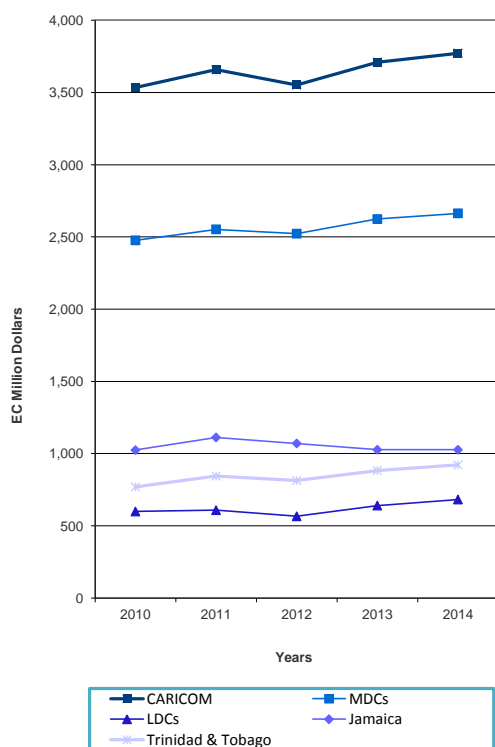

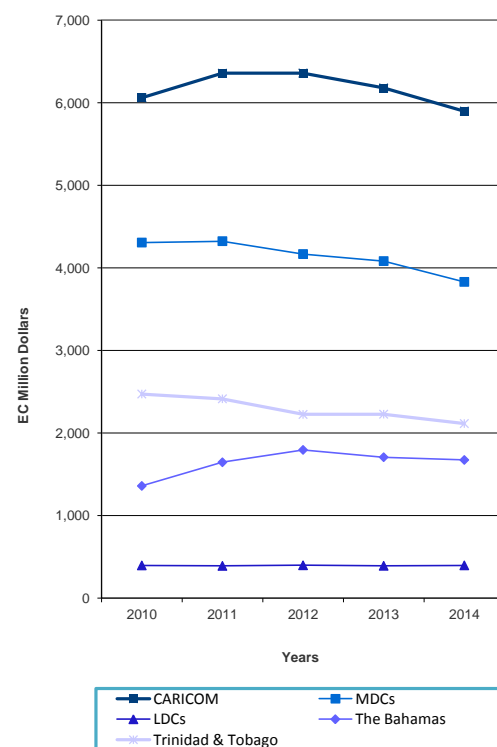

Notes about the Data

Output by industrial origin is classified according to the International Standard Industrial Classification (ISIC). Most Member States have been using adaptations of either the ISIC revision 3 or 3.1; The Bahamas is the only Member States, so far, that has migrated to ISIC Rev. 4.

For the purpose of this report, **Agriculture** includes hunting, forestry and fishing while **Services** comprises construction, wholesale and retail trade, hotels and restaurants, transportation and communication, financial services and business activities, government services, personal and community services and other general services. **Utilities** refers to electricity, gas and water supply. In the case of Guyana, prior to 2006, **Electricity, gas and water** was included in the **Other personal and community services** category and therefore could not be disaggregated. For the period 2010-2014, **Construction** data for Trinidad and Tobago are included in **Mining and Quarrying**.

It should be noted that prior to the re-basing of Suriname's GDP series to the year 2007, data on the informal sector were identified separately in the GDP estimates. For this report, the informal sector has been included in **Services** for the year 2005.

The first six tables presented in this section give a broad indication of the structure of the economy of each CARICOM country by major industry group. According to the System of National Accounts (SNA), Financial Intermediation Services Indirectly Measured (FISIM) should be deducted from individual industries; however, Suriname is the only country that has so far implemented this recommendation. Data at the industry level for all the other countries therefore, include FISIM; hence the

share of FISIM to total GDP is shown in these tables for reference. The reader should note that the sum of the industries minus FISIM is not equal to 100 percent. The difference is due to the inclusion of taxes minus subsidies on products in the calculation of GDP at market prices (see note on page 14).

The following six tables present data on each Member State's percentage contribution to CARICOM's total GDP of the five broad industrial sectors and FISIM. The final six tables provide the absolute values in Eastern Caribbean (EC) dollars.

The reader should note that these indicators would also be affected by the limitations concerning exchange rate conversions as mentioned in the previous Section of this report.

Concepts and Definitions

Value Added/Output

Gross Output of industries is defined as the total value of all goods and services produced during the accounting period, adjusted for change in stock of work-in-progress and finished goods. Intermediate consumption consists of non-durable goods and services, which are used up in production. Value added at market prices is equal to the Gross Output at producers' prices less the value of intermediate consumption at purchasers' prices. The structure of production shows the breakdown of GDP through the contribution of agriculture, industry, services and utilities.

Sources of Data

The structure of GDP was prepared from data compiled by the National

Statistics Offices of the Member States and submitted to the Secretariat.

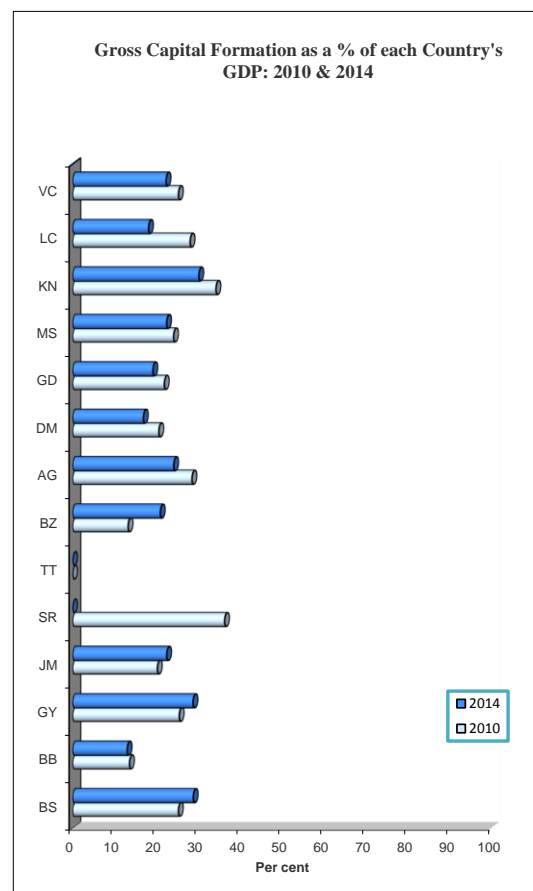
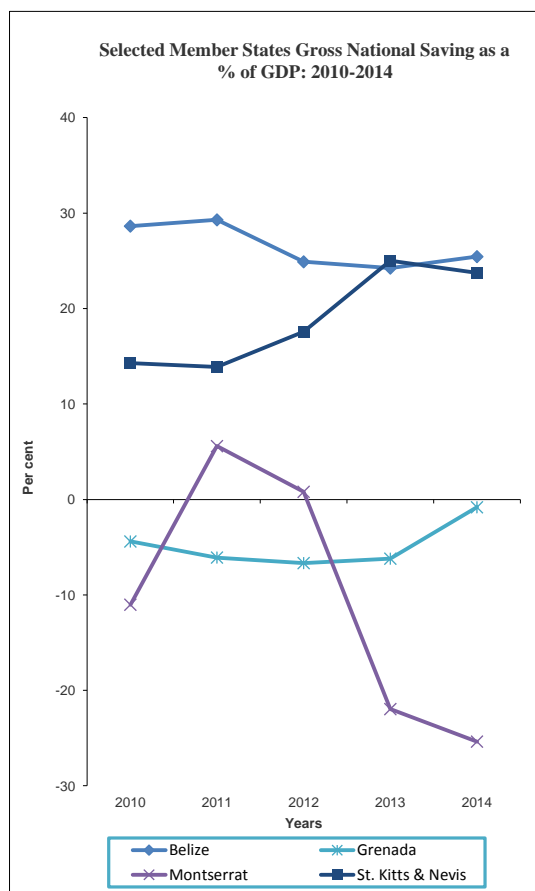

Notes about the Data

There are three approaches for compiling GDP estimates – production, expenditure and income. The tables presented in the previous sections of this report were compiled from primarily from data based on the production approach. In this section, the data were compiled from the expenditure tables of Member States as well as the National Aggregates of the countries.

Sources of Data

Data were extracted from the National Accounts data compiled by the National Statistics Offices of the Member States.

(See Appendix for a complete listing of sources.)

Concepts and Definitions***Gross National Savings***

Savings can be defined as disposable income which is not spent on consumption goods. That is, Disposable Income (National Income plus net transfers from the rest of the world) minus Final Consumption Expenditure (private plus government). The concept of Gross Domestic Savings differs from that of National Savings by not taking into consideration net factor payments from abroad (compensation to employees receivable from abroad and property income receivable from abroad) before subtracting final consumption expenditure.

Gross Domestic Investment

Gross Domestic Investment is gross fixed capital formation and increases in stocks. Gross fixed capital formation consists of outlays and additions to the fixed assets of the economy such as land improvement, plant, machinery and equipment and construction with respect to buildings, residential and commercial, roads, bridges, schools, private dwellings, etc.

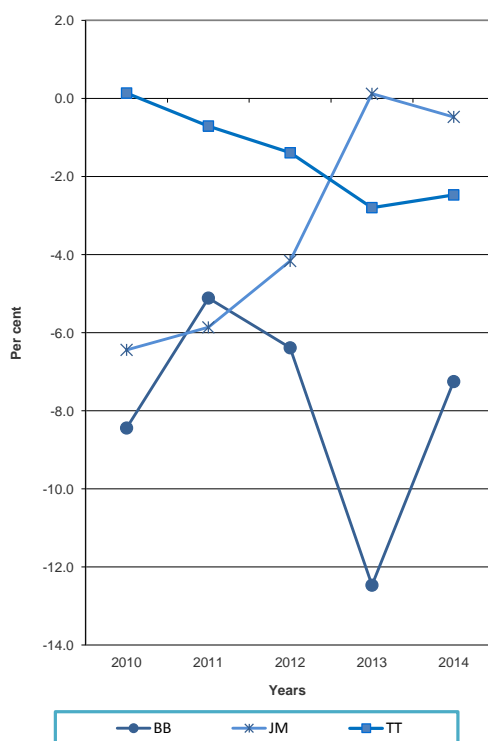
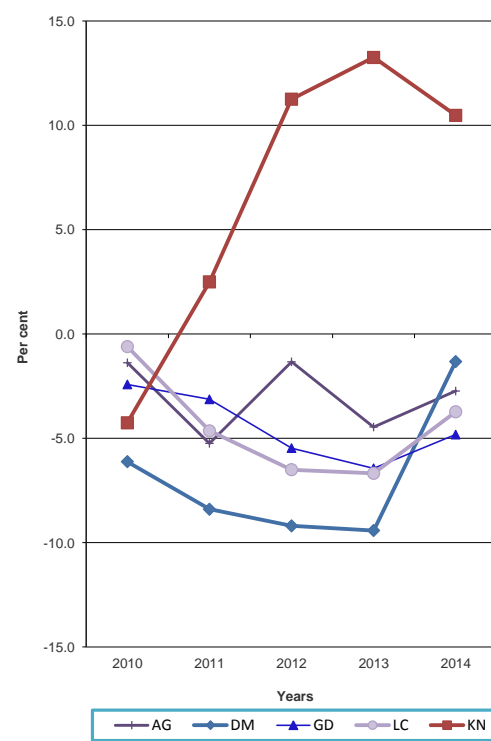

Overall Fiscal deficit/surplus (EC\$ Mn)

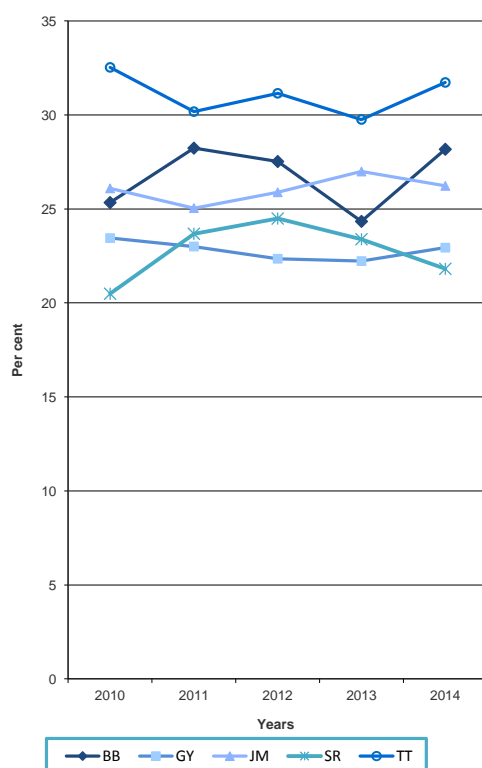

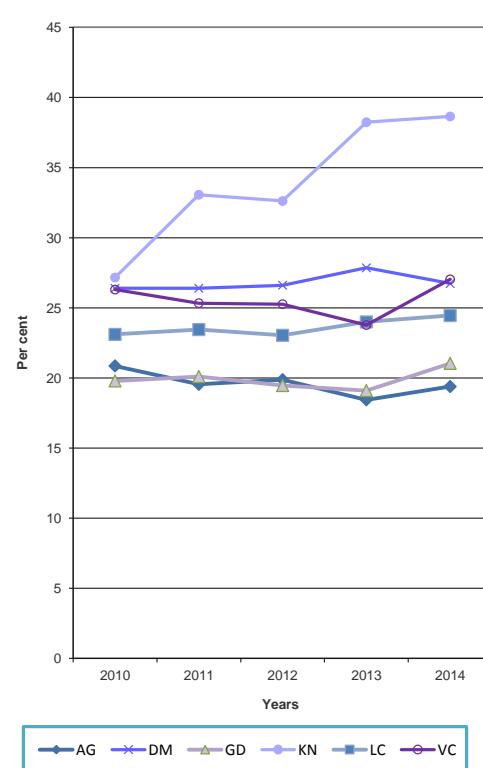

MDCs' Central Government Current Revenue as % of Country's GDP: 2010-2014

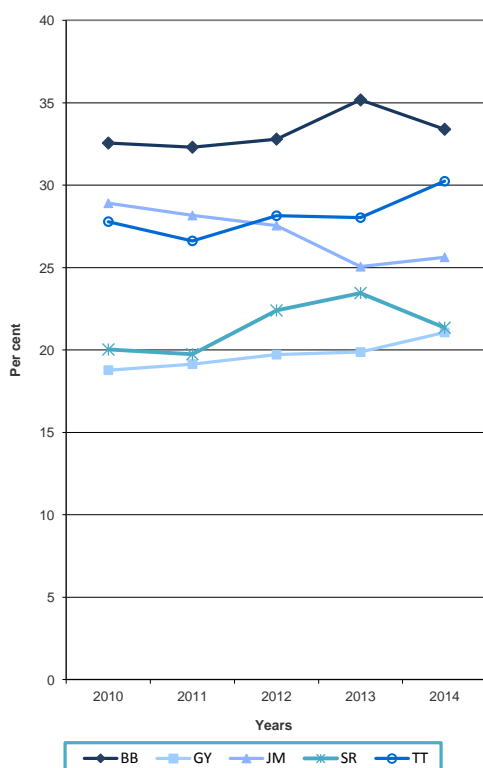

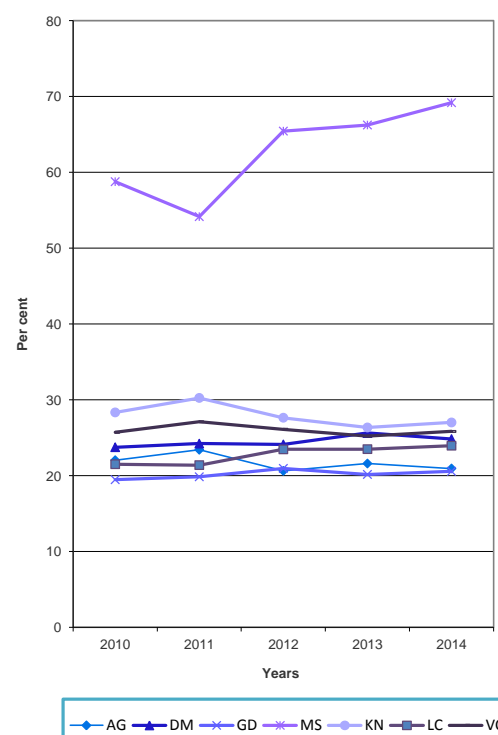

MDCs' Central Government Current Expenditure as % of Country's GDP: 2010-2014

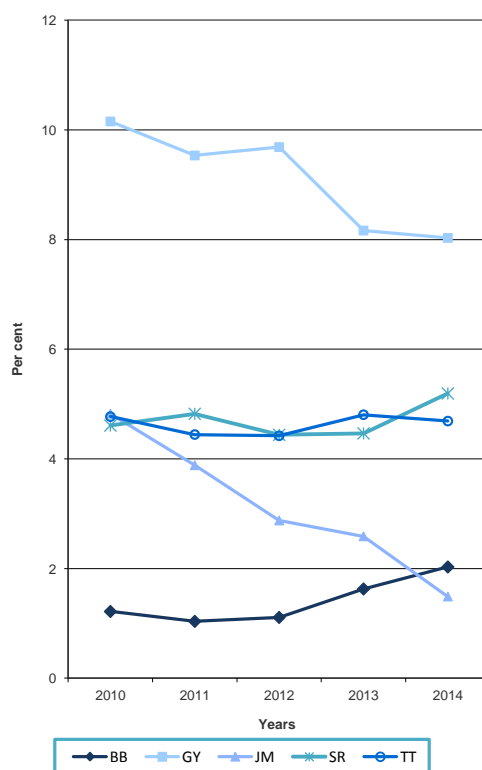

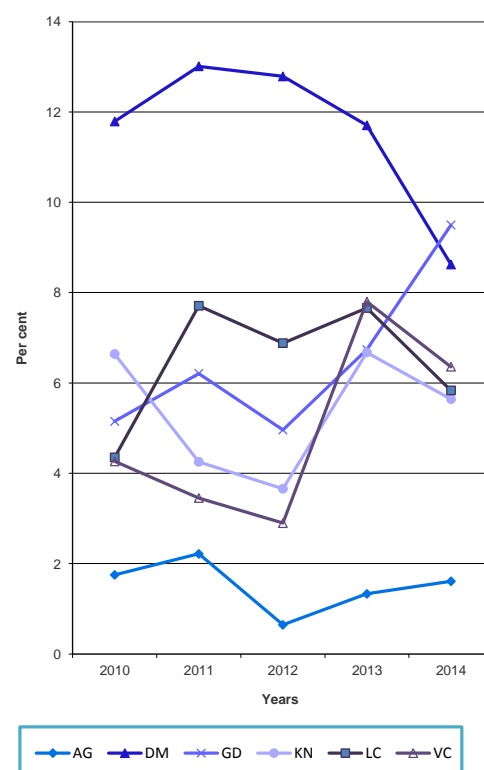

Notes about the data

Government budgetary operations are often based on a fiscal year, which may not always correspond with the calendar year. For all of the countries, except The Bahamas, Barbados, Belize, Jamaica and Trinidad and Tobago, the data extracted from the national sources were reported in calendar years. In order to 'fit' the data for the other five countries into calendar years, the data were placed in the year for which the larger part of the data applied. For example, if the fiscal year ran from April Year (t) to March Year (t+1), as in the case of Barbados, Belize and Jamaica, then the figures were placed in Year (t). The Bahamas' fiscal year, however, runs from July to June. In this case, the data were placed in the year containing the July to December data.

Concepts and Definitions***Government Current Revenue***

Current revenue of government consists of tax revenue and non-tax revenue but excludes capital receipts. Tax revenue covers taxes on income, profits, social security contributions, taxes on property, domestic taxes on goods and services, etc. Non-tax revenue consists of property income, and operating surpluses of departmental enterprises, receipts from public enterprises, voluntary unrequited non-repayable receipts other than from government, administrative fees and charges, fines, etc.

Government Current Expenditure

Current expenditure of government comprises expenditure on goods and services, interest payments and subsidies and other current transfers. It excludes capital expenditure.

Government Capital Expenditure

Capital expenditure comprises expenditure for the acquisition of land, intangible assets, government stocks, and non-military and non-financial assets as well as capital grants and lending minus repayments.

Overall Budget Deficit

The overall government budget deficit is total revenue, current and capital and official grants less total expenditure and net lending (minus payments).

Sources of Data

The main sources for the Central Government data were the reports and web sites of the Central Banks of the Member States and the Eastern Caribbean Central Bank (ECCB).

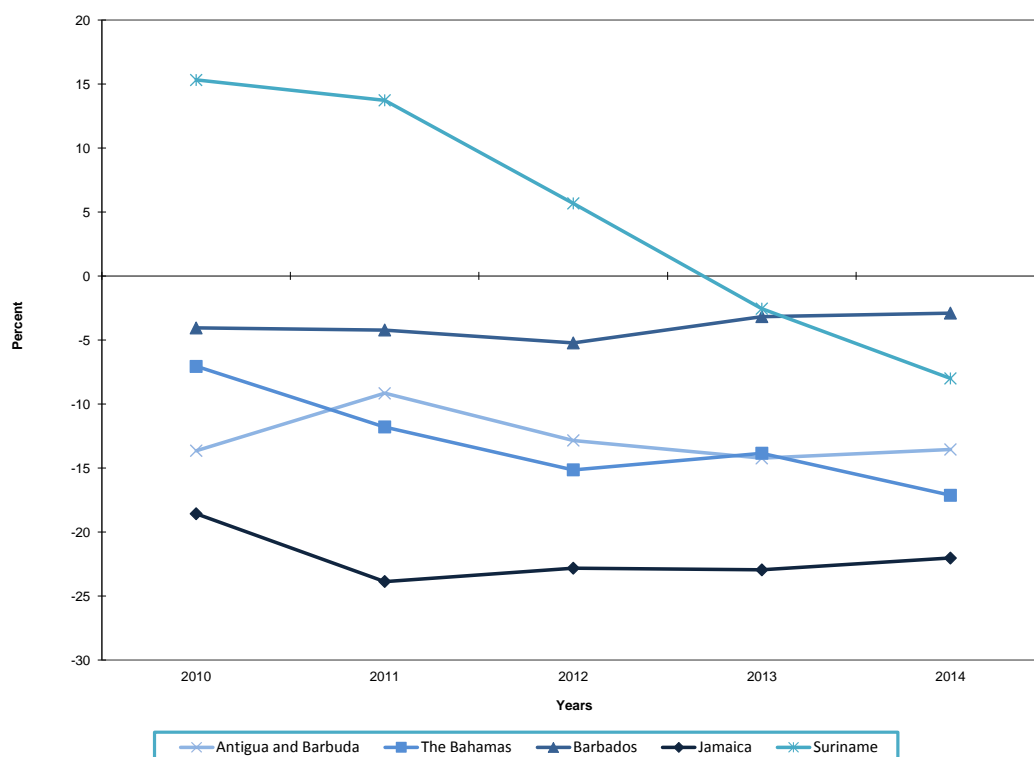

Selected Member States' Net Trade in Goods and Services as a percentage of GDP: 2010-2014



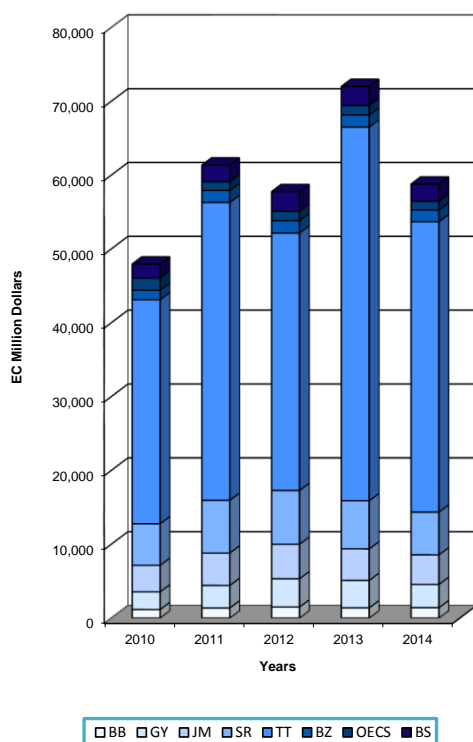

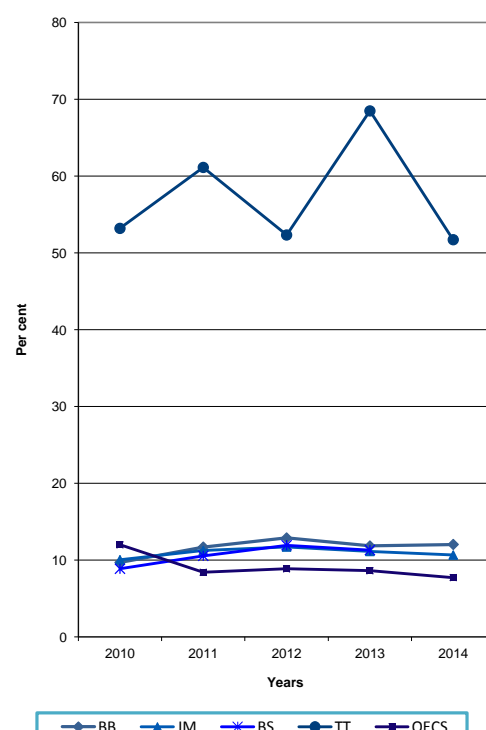

Selected Member States' Exports of Goods as % of Country's GDP: 2010-2014

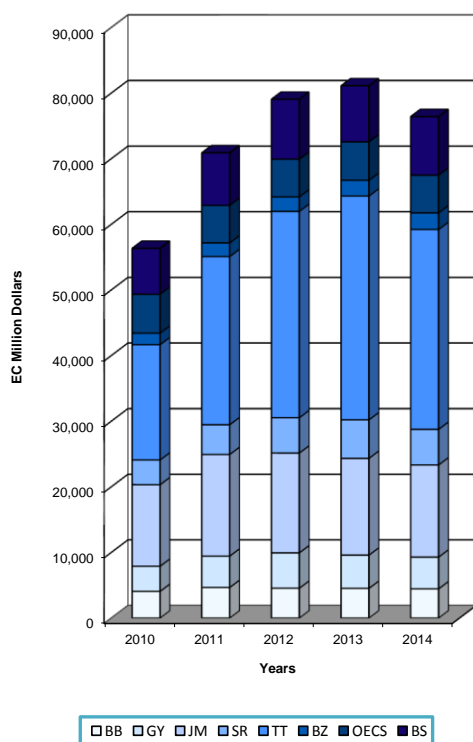

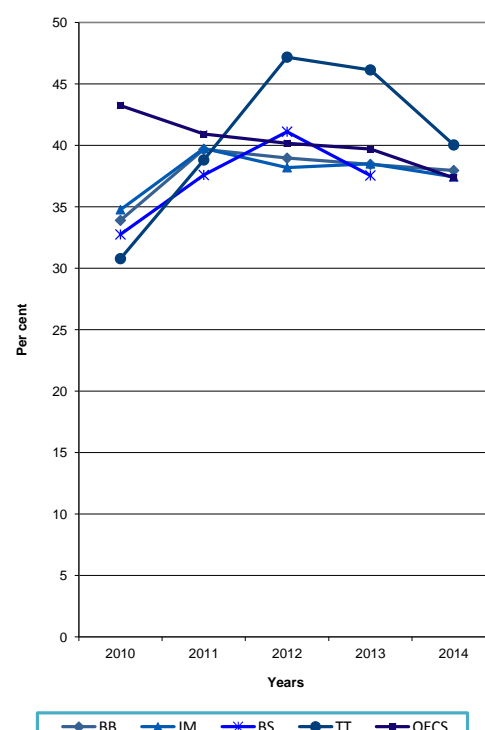

CARICOM's Imports of Goods: 2010-2014



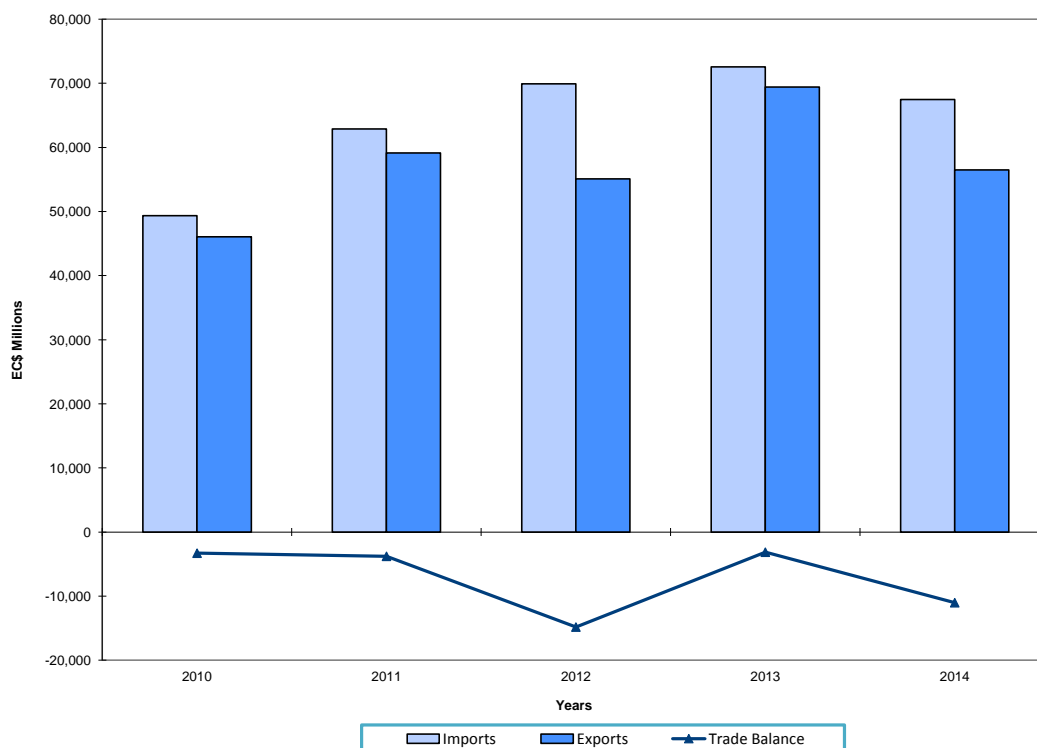
Selected Member States' Imports of Goods as % of Country's GDP: 2010-2014

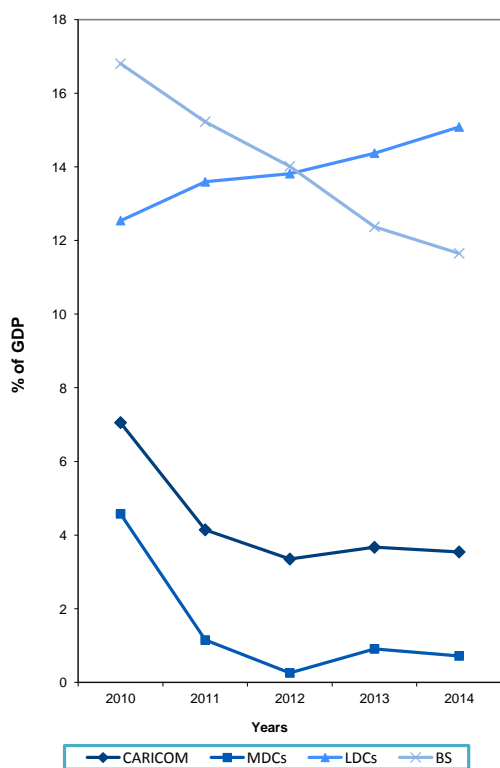

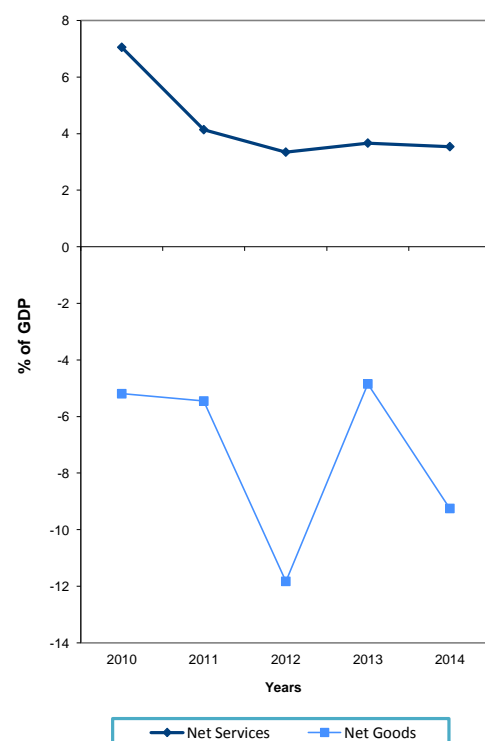

CARICOM - Net Services and Net Goods: 2010-2014



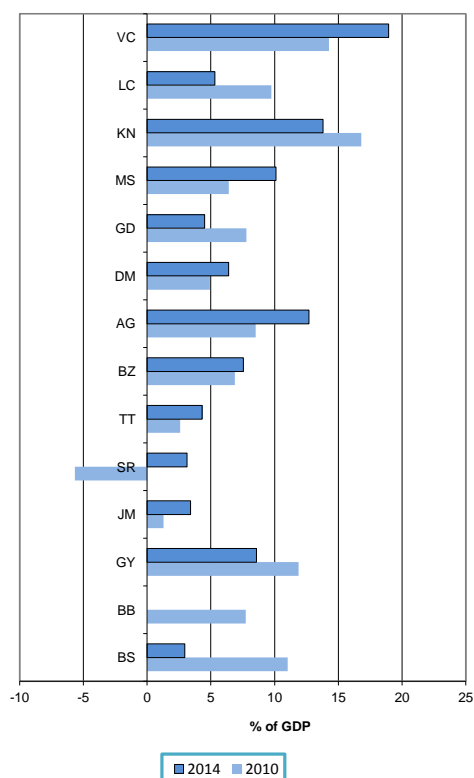

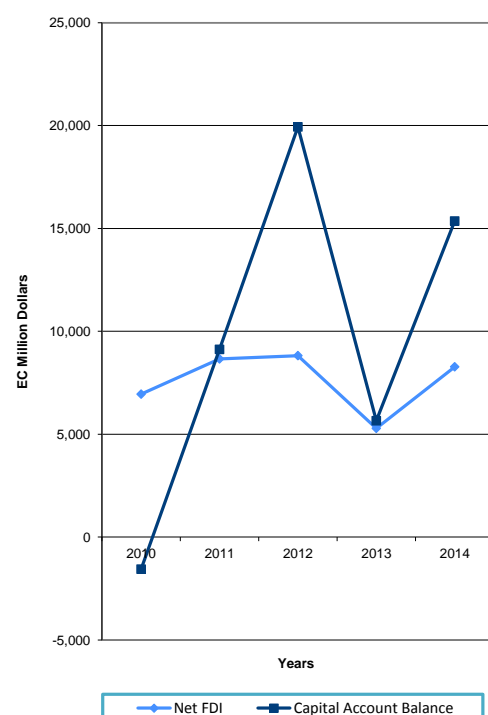

CARICOM - Net Foreign Direct Investment and Capital Account Balance: 2010-2014

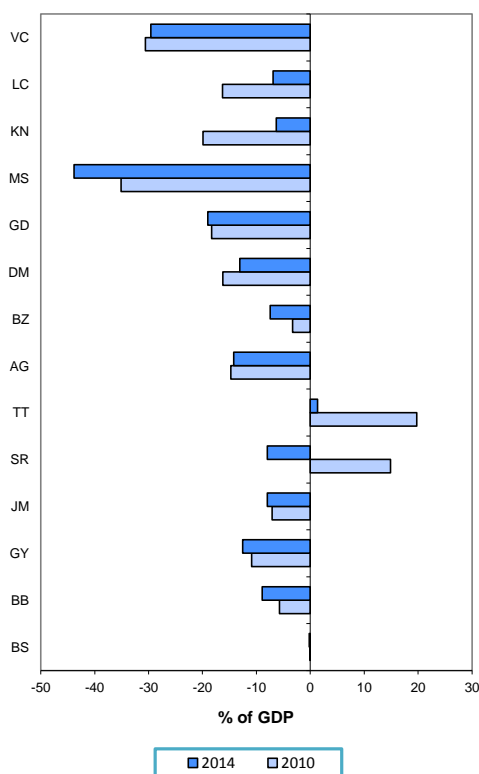

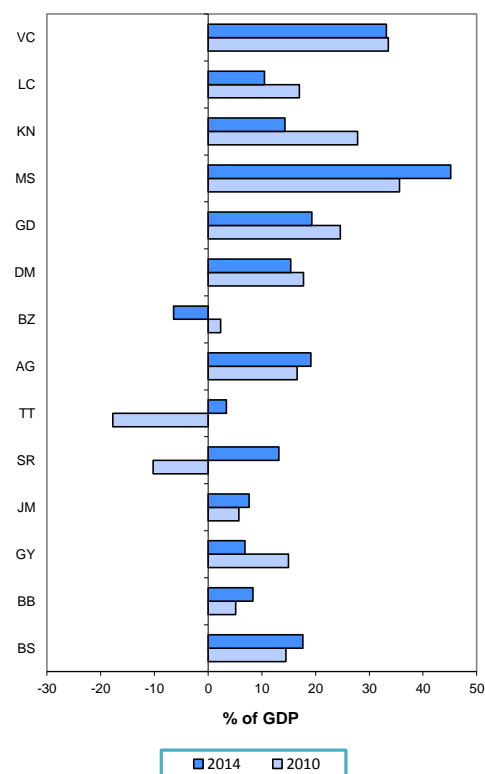

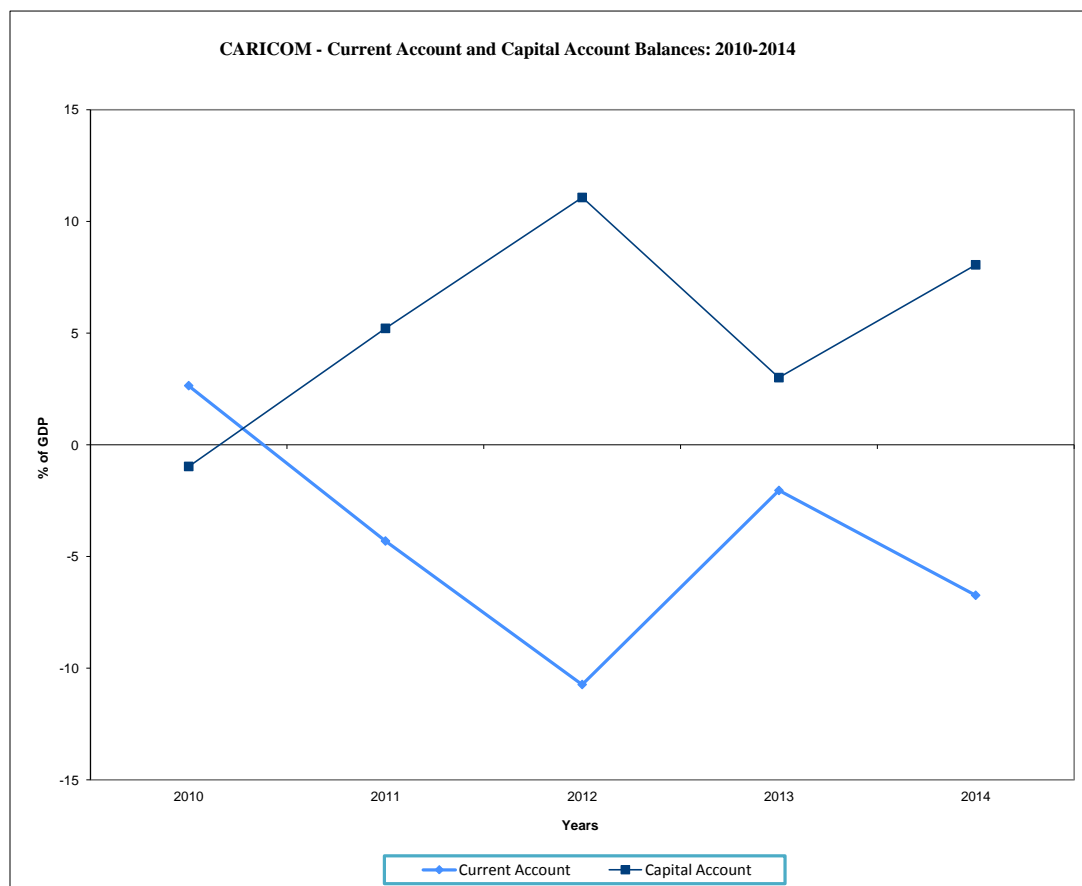
Current Account Balance of CARICOM Member States: 2010 & 2014



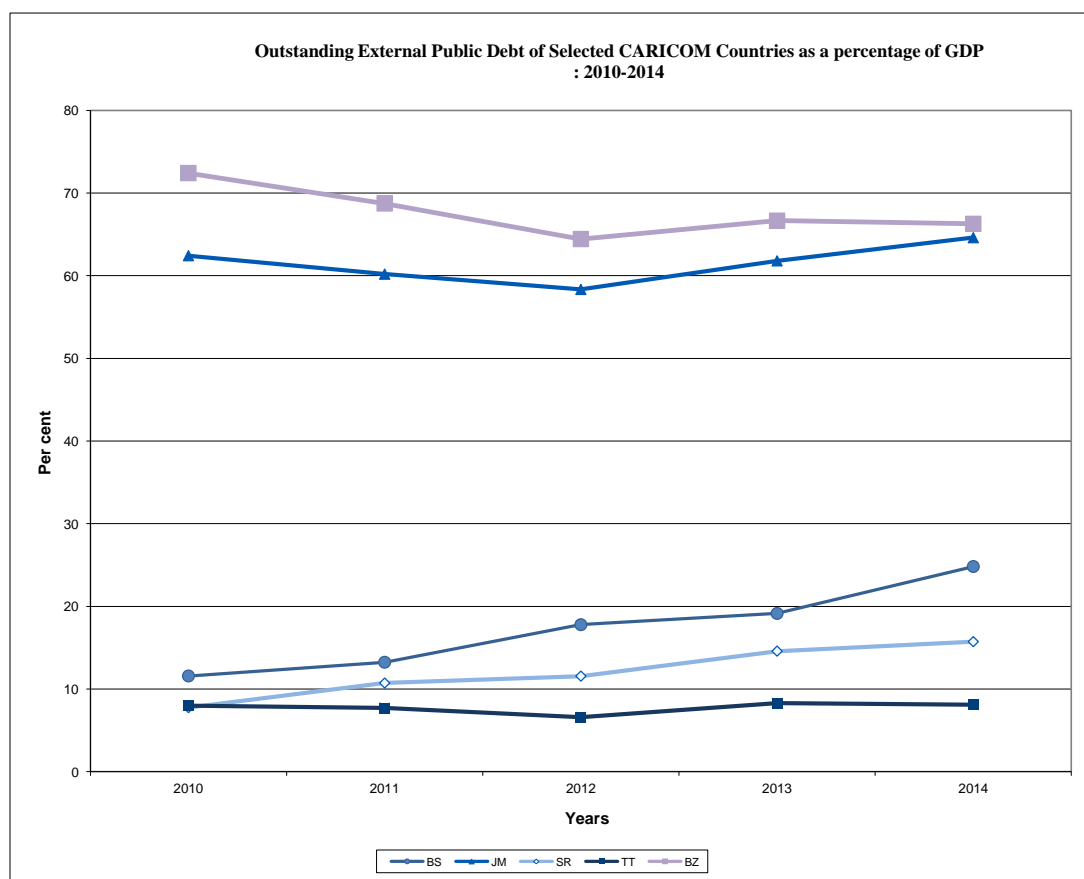
Capital Account Balance of CARICOM Member States: 2010 & 2014



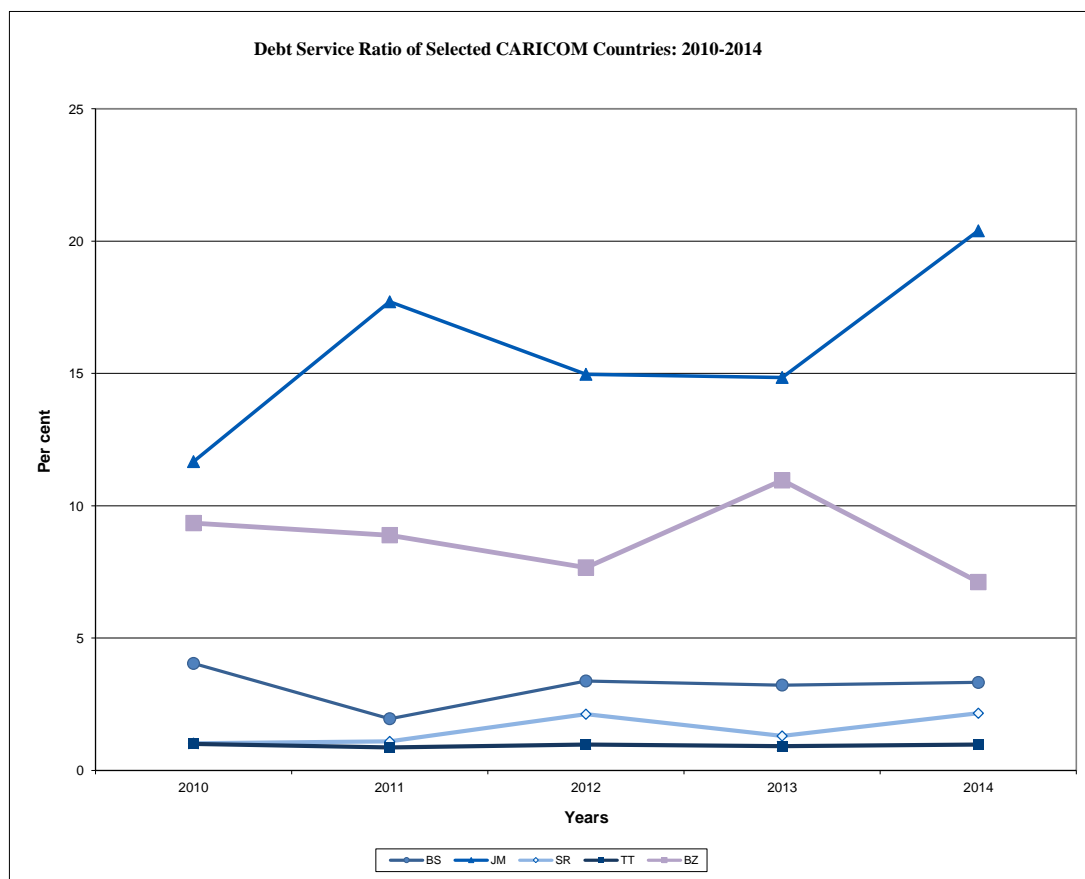

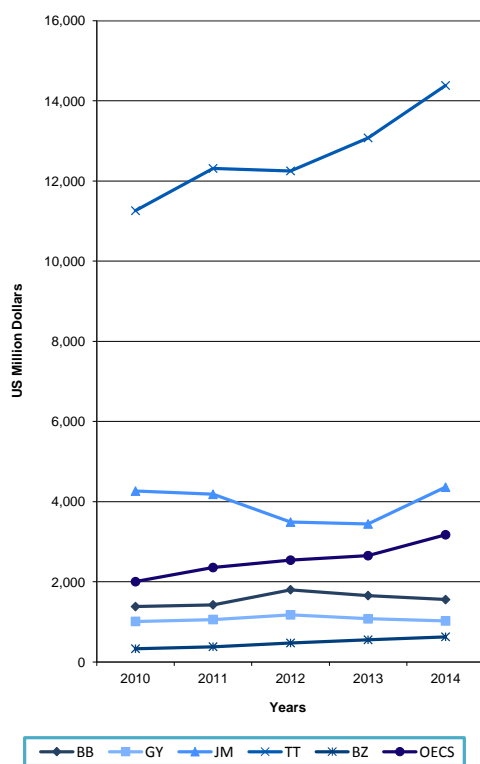

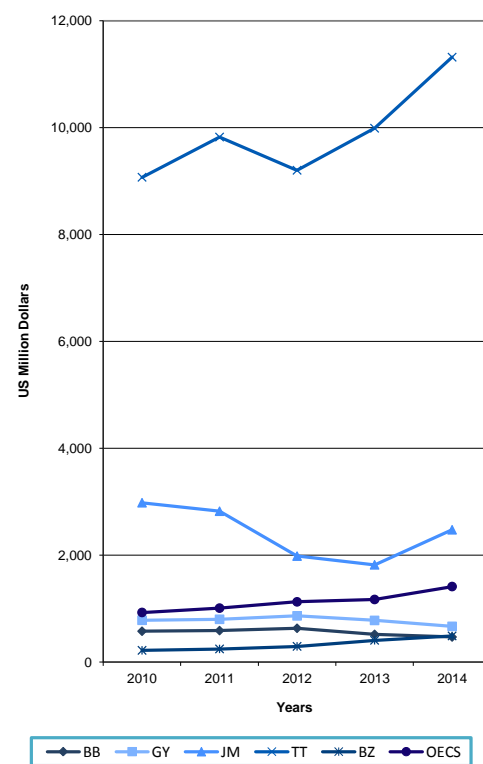

Notes about the data

Exports and Imports of Goods and Services

Merchandise (goods) trade data were extracted from the Balance of Payments of each Member State. Accordingly, the data are valued as free on board (f.o.b) as recommended by the international balance of payments framework. The exceptions are Guyana and Trinidad and Tobago which used the cost, insurance and freight (c.i.f) valuation for their imports data. The trade balance is simply the difference between the exports and imports.

It should be noted that data on merchandise trade are originally captured by the Customs Department in each Member State but may differ from those in the Balance of Payments due to differences in valuation, classification, coverage and the timing of recording. As a result of these differences, the data in this Section will deviate from those presented in the *Selected Economic Indicators* summary table at the front of this report. The data that are provided in the summary table were extracted from the original Customs data which were processed by the NSO.

Net Foreign Direct Investment

The data presented in this table refer to the net inflows of foreign investment. Generally, for most Member States outflows are relatively small when compared with inflows.

Current and Capital Account Balances

Data for the Current Account Balance and the Capital Account Balance tables were extracted from the Balance of Payments of the respective Member States.

External Debt and Debt Service

The External Debt and Debt Service data in this report refer to Public External Debt only and does not include private debt.

The ratio of *External Debt Outstanding to GDP* and the *Debt Service Ratio* are presented as reported by the relevant debt authority in the respective Member State. These may differ from similar ratios calculated by the reader based on the data in this report which might have been revised.

Gross International Reserves

There is only one monetary authority for the member countries of the Organisation of Eastern Caribbean States (OECS), namely the Eastern Caribbean Central Bank (ECCB), hence the Gross International Reserves of the member governments of this institution are pooled into one reserve. As a result, it is not possible to calculate the gross reserves of any one country of the OECS. Rather, the reserves are given for the entire Eastern Caribbean Currency Union (ECCU) area, which includes the seven CARICOM Member States and Anguilla. It should be noted, however, that the foreign assets of commercial banks in Anguilla have been excluded from the gross reserves reported in this section.

Gross Official Reserves have also been presented where these data were available. The official reserves do not include the foreign assets of the commercial banks.

Concepts and Definitions

Exports and Imports of Goods and Services

The value of exports and imports covers international movements of goods and non-factor services across customs borders. Exports are valued at free on board (f.o.b) and imports at cost, insurance, freight (c.i.f). Exports and imports of goods and services include all transactions involving a change of ownership of goods and services between residents of a country and the rest of the world, including merchandise goods and services.

Trade Balance

The trade balance is the difference between exports and imports of goods and non-factor services.

Foreign Direct Investment

Foreign direct investment refers to investment in which the investor has some kind of permanent interest in an enterprise located in a foreign country and exercises some control over its management. The non-resident investor holds or controls 10% or more of the voting stock.

Current Account Balance

The Current Account balance is the sum of net exports of goods and non-factor services (exports less imports), net factor service income, and net transfer payments. Official grants are included in this balance.

Capital and Financial Account Balance

The Capital and Financial Account balance comprises net capital transfers and acquisition/disposal of non-produced, non-financial assets, net direct investment, net portfolio investment, other net investment, including Public Sector Capital, and net reserve assets.

External Debt Outstanding

Total external debt outstanding includes all external obligation of both public and private debtors with maturity of more than one year. It comprises both public and publicly and privately guaranteed debt. This is therefore the total debt owed to non-residents of a country by a national government, public agency and other autonomous bodies as well as private guaranteed debt. This value divided by the GDP gives a picture of the total debt obligations relative to the productive capacity of a country. The higher this ratio is the greater the burden on future generations relative to the liquidation of this debt.

Debt Service Payments

Debt service payments are the sum of repayments of principal (amortisation) and interest actually made by a borrowing country in a specific year. The debt service ratio gives the total debt service payments to exports of goods and services, and reflects the percentage of foreign exchange earnings from exports that must be used to service the debt obligation each year.

Gross International Reserves

Gross international reserves is the sum of all the gross foreign assets of the Central Bank and commercial banks of a country. These include monetary gold holdings, IMF Reserve Tranche Position, SDR's holdings and foreign currency balances.

Payments tables of Member States which were prepared by the Central Banks of the Member States and the ECCB, in the case of the OECS countries. External Public Debt data were supplied by the Central Banks or the Ministries of Finance of the Member States. (See Appendix for a complete listing of sources.)

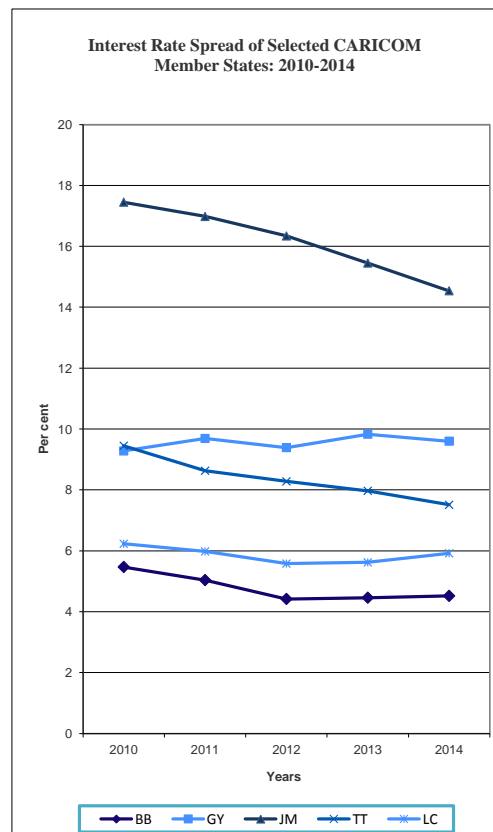
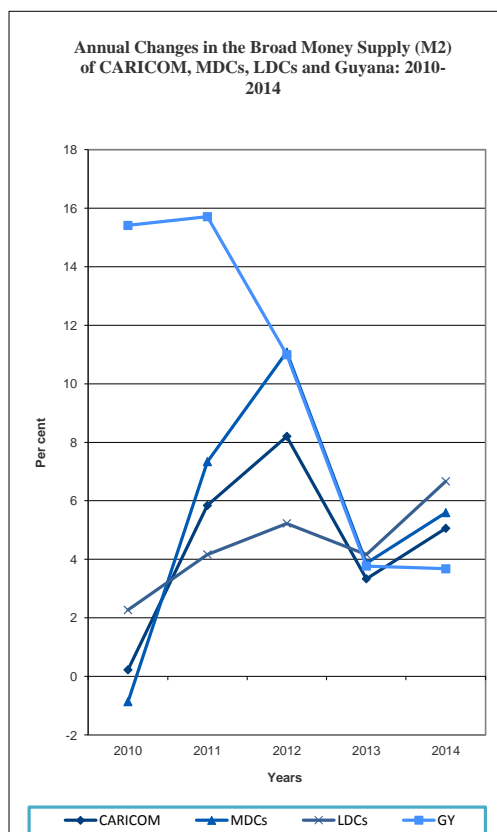
CARICOM, MDCs and LDCs' Domestic Credit to Private Sector as a % of Grouping's Total Liabilities: 2010-2014



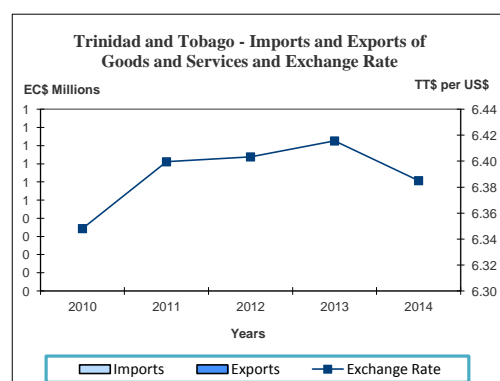
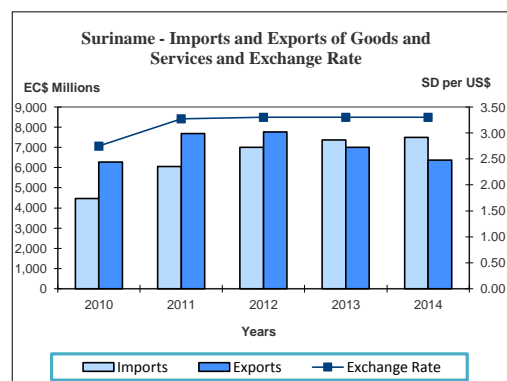
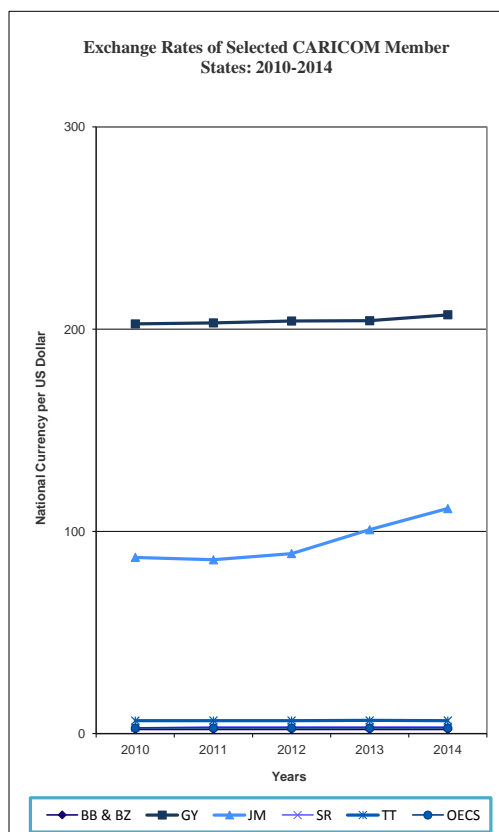
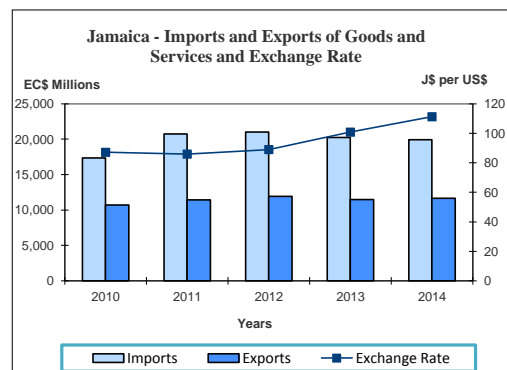
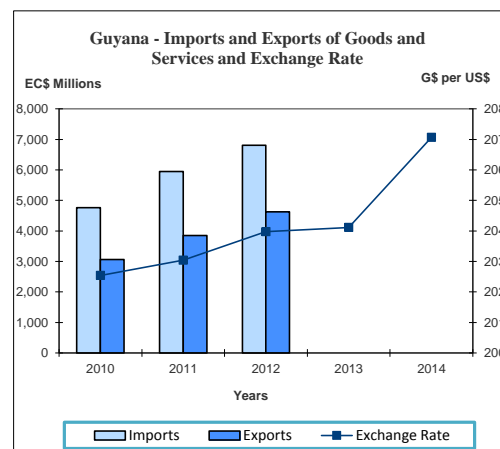
Selected Member States' Domestic Credit to Private Sector as a % of Country's Total Liabilities: 2010-2014

Notes about the data

For comparison purposes, these indicators were calculated as a percentage of the total liabilities of the Central Bank and commercial banks of the respective countries. However, since the OECS countries do not have individual central banks – they are members of the ECCB – the percentages for these countries were calculated using the total liabilities figure of the entire ECCU Area minus the liabilities of the commercial banks in Anguilla, which is not a member state of CARICOM.

Data for The Bahamas were extracted from the Monetary Survey prepared by the Central Bank of The Bahamas. In addition to the Monetary Survey, the Central Bank also prepares a Financial Survey. The Financial Survey includes combined data from the Central Bank, commercial banks and other local financial institutions. The Monetary Survey, on the other hand, does not include data from the other local financial institutions.

Money – M2

With respect to the treatment of foreign currency deposits by residents, the OECS member countries, The Bahamas, Barbados, Belize and Trinidad and Tobago included foreign currency deposits by residents in the money supply (M2). Jamaica included foreign currency deposits but did not state whether this was by residents only, while Guyana and Suriname did not explicitly state whether or not foreign currency deposits were included.

Interest Rate Spread

Guyana's interest rate spread was calculated as the difference between the weighted average lending rate of the Commercial Banks and the small savings rate¹. The interest rate spread for the other Member States was calculated using the weighted average interest rates for loans and deposits.

In the case of Jamaica, Suriname and Trinidad and Tobago, the interest rate spread refers to local currency deposits and loans.

Rates for Barbados, Belize, Guyana and Jamaica were reported as at the end of December.

Concepts and Definitions**Net Foreign Assets**

The net foreign assets position is the total gross assets less total gross liabilities

Net Domestic Credit

Net domestic credit is the sum of domestic credit to the central government, public sector and private sector added to time, savings and foreign currency deposits and other items (valuations).

Domestic Credit to the Private Sector

The domestic credit to the private sector represents commercial banks' investment in time deposits, marketable stock, other private sector securities and total loans to the private sector.

Money Supply – M2

Money supply, M-2, is defined as the sum of currency in active circulation, commercial banks' reserves with the Central bank, demand deposits, savings deposits and time deposits.

Interest Rate Spread

The difference between the weighted average interest rates on loans and deposits is the interest rate spread.

Nominal Exchange Rate

The nominal exchange rate is the country's official exchange rate to some other country's currency, in this case, the US dollar. The exchange rate may be fixed and is therefore determined by the official authorities. The exchange rate can be flexible or floating, determined by the market forces or might be managed floating.

Sources of Data

The data were extracted from the Central Bank reports or web sites of the respective Member State.
