

CARICOM's Trade with the United Kingdom

CARICOM'S TRADE WITH THE UNITED KINGDOM: 2011-2016

- CARICOM's imports from the United Kingdom stood US\$0.5 billion in 2011 (all Member States reporting) and 2016 (twelve Member States reporting)¹. The United Kingdom as a source of CARICOM's imports accounted on average for 2.2% of CARICOM's total imports over the period, 2011-2016.
- CARICOM's exports to the United Kingdom dropped from US\$0.7 billion in 2011 (twelve Member States reporting)¹ to US\$0.3 billion in 2016 (eleven Member States reporting)². The United Kingdom on average accounted for 2.8% of CARICOM's total exports to all destinations over the period.
- Overall CARICOM's trade balance with the United Kingdom *reflected surpluses* in 2011 and 2012 and deficits for the period 2013-2016. In 2011, the *surplus* stood at US\$0.2 billion while in 2016, the deficit was US\$0.2 billion.


Major Contributors


Imports

- The MDCs dominated CARICOM's imports from the United Kingdom with an average percentage contribution of 78.9% over the period. The MDCs' imports from the United Kingdom stood at approximately US\$0.4 billion in 2011 and 2016 which accounted for 76.9% and 78.2% respectively of CARICOM's imports from this trading partner.
- The percentage contribution of the LDCs to CARICOM's imports from the United Kingdom decreased from 23.1% in 2011 to 21.8% in 2016.

Exports


- The MDCs also dominated CARICOM's exports to the United Kingdom with an average percentage contribution of 78.1%. Exports of the MDCs to the United Kingdom decreased from US\$0.6 billion in 2011 to US\$0.2 billion in 2016, which represented 88.3% and 67.2% of CARICOM's exports to the United Kingdom in the respective years.
- Over the period, the LDCs on average accounted for 21.9% of CARICOM's exports to the United Kingdom of which Belize on average represented 16.2%.






Member States Contributions

- *Trinidad and Tobago* and *Jamaica* were CARICOM's two leading importers from the United Kingdom. These Member States on average accounted for 41.4% and 14.1% of the Region's imports from this trading partner over the period.
- The OECS countries on average accounted for 18.7% of CARICOM's imports from the United Kingdom of which *Saint Lucia* on average accounted for 5.4%.
- With regards to exports, *Trinidad and Tobago* and *Guyana* were the Region's largest exporters to the United Kingdom with average percentage contributions of 41.2% and 17.8% respectively.
- *Belize*, the top LDCs Member State to export to the United Kingdom accounted on average for 16.2% of the Region's exports to the United Kingdom over the period.






Major Commodity Grouping


• CARICOM's major commodity groupings imported from the United Kingdom were Machinery and Transport Equipment; Chemicals and related products; and Miscellaneous manufactured

Articles while the major commodity groupings exported to the United Kingdom were Food; Chemicals and related products; and Mineral fuels, lubricants and related products.

• With regards to CARICOM's imports from the United Kingdom, *Machinery and Transport Equipment* on average accounted for 38.2% while *Chemicals and related products*; and *Miscellaneous manufactured articles* represented for 14.6% and 13.5% respectively. Collectively these three commodity groupings accounted on average for 66.2% of CARICOM's imports from the United Kingdom over the period.



• On the export side, *Food* on average represented 44.4% of CARICOM's exports to the United Kingdom while *Chemicals and related products*; and *Mineral fuels, lubricants and related products* on average accounted for 18.5% and 16.5% respectively of the Region's exports to this trading partner.



Top items traded with the United Kingdom - 2016

- CARICOM's top ten imports from the United Kingdom for 2016 accounted for 39.9% of its total imports from the United Kingdom. The top five commodities were:
 - Motor cars and other motor vehicles principally designed for the transport of persons (other than motor vehicles for the transport of ten or more persons, including the driver), including station-wagons and racing cars;
 - Medicaments (including veterinary medicaments);
 - Alcoholic beverages;
 - o Civil engineering and contractors' plant and equipment; parts thereof; and
 - Printed matter.

These five commodities collectively accounted for 26.3% of the Region's total imports from the United Kingdom.

- On the exports side, CARICOM's top ten domestic exports to the United Kingdom accounted for 90.2% of its total domestic exports to this trading partner in 2016. The top five commodities were:
 - Sugars, molasses and honey;

- Alcohols, phenols, phenol-alcohols, and their halogenated, sulphonated, nitrated or nitrosated derivatives;
- o Fruit and nuts (not including oil nuts), fresh or dried;
- o Alcoholic beverages; and
- o Natural gas, whether or not liquefied.

These five commodities collectively accounted for 82.6% of CARICOM's total domestic exports to the United Kingdom.






